Dear Mr. Steele:

I am writing to express the Greater Houston Partnership's (GHP) support for the recommendation of utilizing Transportation Improvement Program (TIP) funding to close existing trail gaps on both Hunting and Halls Bayous.

GHP's principal objective is to build regional economic prosperity. GHP understands that economic prosperity requires improving the Houston region's quality of life by building a network of shared use paths along the many bayous in Houston that will be used as important transportation corridors for Houston's cyclists, runners and pedestrians. Additionally, we believe these advancements will improve Houston's tax base through increased property values and will stimulate private development along the bayou corridors.

The Halls Bayou Gap Project fills a gap between 5.6 miles of safe, off-street shared use paths, as well as extends the eastern portion of the proposed trail to a street connection at the intersection of Tidwell and Wayside to provide additional transit options. Total funding requested in the TIP is \$3,182,584. The Hunting Bayou Gap Project fills a gap in the existing off-road shared use path along Hunting Bayou and will connect portions of trails to the west (leading to Mickey Leeland Park) to neighborhoods to the east through Hutcheson Park. Total funding requested in the TIP is \$453,314.

By connecting residential neighborhoods to employment centers, education facilities, public transportation and recreation via off-street bicycle and pedestrian paths, the proposed project makes safe, affordable transportation options available to more Houstonians.
