

11.B REGIONAL TRANSPORTATION PLAN PUBLIC MEETING SCHEDULE

BACKGROUND

The Regional Transportation Plan (RTP) is a strategy to utilize federal, state, and local resources for transportation investments in the region and must be updated every four (4) years. The RTP includes a framework of existing and forecasted conditions, a vision and goals for prioritizing projects and programs, and a fiscally constrained action plan for at least the next 20 years. The RTP was last approved by the Transportation Policy Council (TPC) on May 14, 2019 with the update scheduled to be approved on April 28, 2023.

The RTP must be developed in coordination with transportation stakeholders and the general public. This outreach consists of three phases – a Visioning, Prioritization, and a Draft Review phase. The Visioning phase was conducted from May through July 2022 and included virtual and in-person meetings to encourage participation in a Visioning Survey. The Prioritization phase is being conducted in October through early December 2022 to share survey responses and gather feedback on strategies to address what we have heard to date. Once the Prioritization phase is complete, staff will develop the draft RTP for the Draft Review phase in February and March 2023.

CURRENT SITUATION

The Prioritization phase utilizes the www.h-gac.com/rtp website to share a recorded presentation of the Visioning survey responses, strategies to address challenges and needs, and a survey to solicit feedback on these strategies. H-GAC staff has also scheduled seven (7) in-person events around the region to solicit public input ([event flyer](#)). The priority of this outreach is to solicit feedback on the strategies, which are Safety, Reliability, Equity, Analytics, Livability, and Public Participation. The in-person meetings are as follows:
