Title VI of the Civil Rights Act of 1964

- Federal law that prohibits discrimination on the basis of race, color, or national origin in all programs and activities receiving federal funding

Americans with Disabilities Act (ADA)

- Federal law that prohibits discrimination against people with disabilities in employment, transportation, public accommodation, communications, and access to government programs and services

Executive Order 12898

- Federal Actions to Address Environmental Justice in Minority Populations and Low-Income Populations
- Focuses on environmental and health effects of federal actions on minority and low-income populations

- No population should bear a disproportionate share of negative environmental consequences

Executive Order 13166


- Improving Access to Services for Persons with Limited English Proficiency (LEP)
- Requires federal agencies to examine their services, and to develop and implement a system to increase accessibility for LEP individuals

Executive Order 13985

- Advancing Racial Equity and Support for Underserved Communities through the Federal Government
 - Requires federal agencies to examine if their policies and practices contribute to inequities in service access, utilization, and outcomes
 - Establishes requirements on the Office of Management Budget (OMB) Director and executive departments to take proactive steps to eliminate barriers to equal opportunity for underserved communities


Justice 40

- Aims to deliver 40 percent of the overall benefits of relevant federal investments to disadvantaged communities
- Addresses inequities that hinder sustainable, just society, and that disproportionately harm low-income and communities of color

Equality, Equity, & Justice: Defined

Equality



The assumption is that **everyone benefits from the same supports**. This is equal treatment.

Equity



Everyone gets the supports they need (this is the concept of "affirmative action"), thus producing equity.

Justice



All 3 can see the game without supports or accommodations because **the cause(s) of the inequity was addressed**. The systemic barrier has been removed.

DEI in a Transportation Context

Diversity

Does the transportation network provide adequate access to opportunity for all populations?

Equity

Do all persons regardless of race, income, gender, ability have equitable access to safe, affordable, and reliable transportation?

Inclusion

What groups have been traditionally underserved by transportation processes? How can they be more effectively involved in the transportation decision-making process to create a system that benefits them?

Assessing Benefits and Burdens in Transportation

- Ensure that plans, project elements, and policies advance the needs of underserved populations
- Identify if actions introduce any barriers, disrupt access, cause displacement, or create health and safety hazards






Locate Traditionally Underserved Communities

- Communities whose needs have traditionally been underserved in the transportation planning process
- Populations may include low-income and
 - Minority
 - Older adults
 - Young persons
 - Women
 - Persons with disabilities
 - Single-parent households
 - Zero-vehicle
 - Limited English Proficiency (LEP)
 - LGBTQ+
 - Other underserved or disadvantaged populations groups



Individuals may belong to more than one underserved community and face intersecting barriers.

2021 Household Expenditures





Share of Income Spent on Transportation

Households in the **lowest income quintile** spent the **least on transportation** ... but faced a **larger transportation cost burden**, spending 26.9 percent of their after-tax income on transportation compared to 10.4 percent by the highest income quintile in 2021.





Most Vulnerable Populations


Pedestrian fatalities per 100,000 people by age (2016-2020)



Pedestrian deaths per 100,000 by race & ethnicity (2016-2020)




Pedestrian fatalities per 100,000 people by census tract income




Street Features by Community Income Level

Communities with Sidewalks



Who Has Streets with Lighting?




Inventory & Assess Mobility Needs



Community Engagement and Empowerment

Collaborate and co-create WITH the community

INFORM

Provide the community with balanced, objective information to assist them in understanding the problem and potential opportunities and solutions.

CONSULT

Listen to and acknowledge community concerns and aspirations; provide feedback on how community input is influencing decisions.

INVOLVE

Ensure that community concerns are directly reflected in the alternatives developed.

COLLABORATE

Incorporate community advice and innovation into solutions.

EMPOWER

Place the final decision in the hands of the community.

Methods to Evaluate Community Needs

Prioritize needs

- Identify indicators to measure and prioritize transportation needs
- Conduct a SWOT analysis

Identify and analyze causes

- Root cause analysis
- Cause and consequence analysis



During community meetings ask community members to identify their top transportation challenges/needs.

Equity Indicators

- Affordability
- Safety
- Access/Connectivity (bicycle, pedestrian, transit) to essential destinations
- Travel Time and Distance
- Congested vehicle miles travelled by population segment
- Mode share
- Project investment by population segment
- Environmental Quality/Exposure to emissions and pollution





SWOT Analysis


	Benefits	Burdens
Existing	<p><u>Strengths</u> Existing assets that are beneficial to the community</p>	<p><u>Weaknesses</u> Assets that need improvement or the community lacks</p>
Future	<p><u>Opportunities</u> Trends that can positively impact the community</p>	<p><u>Threats</u> Trends that can create or worsen barriers in the community</p>

Root Cause Analysis

- The “Five Whys”
 - Why does this need exist/continue?
 - How do we know?
- Fishbone diagram




Cause and Consequence Analysis

Need	Causes	Consequences	Difficulty to Correct [low, medium, high]	Criticality 1 2 3 4 5

How Can We Advance Equity in Transportation?



Include equity as a vision and goal



Use an equity lens when evaluating impacts



Systematically prioritize projects for underserved communities



Engage underserved communities throughout the planning and project selection process



Dedicate funding to equity in project prioritization



Be transparent during prioritization and planning



Score and weight equity similar to other criteria



Consider equity from multiple perspectives
