

Goals and Metrics – For Review

Goals (Metrics)


- Provide MOBILITY solutions and travel options for daily travelers (connectivity, gaps, multimodal)
- Increase FREIGHT traffic efficiency (truck travel time, delay, routes and stops, railroad crossings)
- Increase EFFICIENCY at high-congestion corridors and intersections (v/c, LOS, travel time)
- 4. Improve SAFETY at high-crash segments and intersections (crash rates, number of conflict points)
- Enhance ECONOMIC opportunity in focus areas (cross section, access management, economic impact)







Study Corridors & Intersections









WHY A MOBILITY STUDY?

Liberty County is developing quickly. With increasing traffic to the area, especially within the Cities of Cleveland, Dayton and Liberty, the County needs a transportation plan that manages growth, maintains mobility, and focuses on safety for all users, including:

- Cars
- Freight trucks
- PedestriansBicycles
- Public Transit

The Liberty County Mobility Study will define future transportation investments that will move people and goods to and from destinations in a safe and efficient manner.

- The study will: • Analyze the existing transportation network
- , , ,
- Consider existing and future land use and growth scenarios
- Recommend ways to improve transportation mobility for residents, businesses and visitors now and in the future

Development of the Mobility Study will be a collaborative process that analyzes a variety of alternative scenarios, so citizens, stakeholders, and elected officials can make informed decisions about the facilities and policies needed for a growing Liberty County. The analysis and process will be summarized in an implementation and Funding Plan that will have the flexibility to adjust as the County's needs change.


