# 8. AMENDMENT TO THE 2025 UNIFIED PLANNING WORK PROGRAM

# BACKGROUND

The 2025 Unified Planning Work Program (UPWP) describes the regional transportation planning activities that will be undertaken by the Houston-Galveston Area Council Metropolitan Planning Organization during fiscal year 2025. The current 2025 UPWP was adopted by the Transportation Policy Council (TPC) on August 23, 2024, and is available online here: <u>https://www.h-gac.com/unified-planning-work-program</u>.

# CURRENT SITUATION

This amendment to the Unified Planning Work Program makes the following revisions to the 2025 Unified Planning Work Program:

- Page 66: Corrected FTA Funding Section to 5304 in Task III: Short-Range Planning Funding Summary Table. (No fiscal impact).
- Page 76: Added two mobility studies requested by Montgomery County for Montgomery County Precinct 1 and Montgomery County Precinct 4, request letters attached. (No fiscal change. This addition will allow for staff to develop the projects. Funding will be added for these activities once further developed and scoped.)
- Page 109: Corrected Expected Products for Subtask 5.7.a Corridor Planning to include the completion of Washington Avenue Corridor Study, Pearland FM 518 Corridor Study, and Cemetery Road Corridor Study, which are expected to be complete by the end of Federal Fiscal Year 2025.

# Subtask 5.7.b – Project-Level Planning

H-GAC will work with federal, state, and local agencies toward the on-time delivery of federal surface transportation projects selected by the TPC. Projects and plans will be selected through the H-GAC project selection process that are aligned with the current regional transportation plan and the associated air quality conformity determination. Projects identified in the project selection process will be monitored by staff to proactively identify project development concerns that may cause project delays or budget changes.

- B. Complete Streets Planning Website/page to facilitate complete streets planning information exchange and access including the development of the region-wide complete streets plan.

# Subtask 5.7.d – Transit Oriented Development (TOD)

The task will include coordination activities with local governments and public transportation providers to identify opportunities for Transit Oriented Design in conjunction with their plans for existing and proposed services. - D. Support local sponsor/partner in TOD planning efforts, including, but not limited to Tidwell Transit Center along the University Corridor that will enhance connectivity, promote walkability and sustainability, and support equity through economic development and affordable housing, and Gulfton Corridor Transit Oriented Development Plan and Implementation Strategy that will identify community infrastructure needs including improved sidewalks, crosswalks, traffic signals, and bike infrastructure (Partner activities to be completed by METRO.)


