Re: Greater East End Management District

Mr. Clark -

The Greater East End Management District has recently received a high ranking for two applications for federal funding administered through the Houston Galveston Area Council, totaling close to 5.2 million dollars. These projects are part of an overall plan that has already started to transform the District; the proposed projects focus on connectivity, build on earlier projects, and work to help pedestrians and cyclists achieve access to transit. These projects are important also for the following reasons:

- The projects supplement METRO's investment of \$525M in the East End Light Rail; there are no major parking lots along the stops, so the way to get people to ride this line is to build good sidewalks and bike trails.
- The projects will focus on the population in the neighborhood. Over thirty percent of the people in this neighborhood use transit, walk or bike to get to work or school; improvements in the pedestrian and cycling realm to get people to transit helps to make a productive community.
- These projects build onto others that have already been constructed, and are consistent with the East End Mobility Plan; when finished, they will help all travelers move around, including those in cars and buses.

I strongly support the projects under the Pedestrian Bicycle Projects and the Livable Centers. The Bike /Ped project will improve facilities across rail lines and improve safety at rail crossings. The Livable Centers Projects will provide intersection improvements to increase the safety and improve capacity for multimodal travel, as well as improving connectivity between the redeveloping EaDo and East End communities.

I believe that these improvements are consistent with the Regional Transportation Plan, and are particularly important to this area.

Dear Mr. Clark:

This letter is in support of the Greater East End Management District's (GEEMD) two applications for close to \$5.5 million in supplementary funding. This funding will improve the bicycle and pedestrian environments adjacent to METRO'S \$525 million investment in the East End Rail Line and improve capacity and connectivity between the redeveloping East Downtown (EaDo) and East End communities.

As the East End Rail nears completion, the EaDo and East End communities see areas of opportunities for improving bicycle and pedestrian facilities. The establishment of shared use paths on Caylor Street and 65th Street and development of rail crossing improvements on Leeland and McKinney at the Union Pacific Rail Line would provide the cycling and pedestrian community safety to and from transit stops, school and work.

The communities have also expressed their views on the importance of intersection enhancements, improved accessibility and connectivity to bicycle and pedestrian trails, and improved safety measures while increasing capacity for multi-modal travel. With the addition of several sidewalks in the Second Ward neighborhood, to the reconfiguration of the Navigation, St, Emanuel and Franklin intersection and traffic signal installation to the intersection improvements at Navigation and Canal and Navigation Boulevard and Jensen Drive, the thirty four percent of the people in these neighborhoods (my constituents) who are transit dependent or bike and walk to school and work will be able to use all modes of transit safely.

The Greater East End Management District is committed to fulfilling the community's vision.

Let's provide Greater East End Management District the opportunity to make this vision a reality.

On behalf of the 29th Congressional District of Texas, I am pleased to provide this letter of support for the proposals being submitted to the Houston Galveston Area Council (H-GAC) by the Greater East End Management District. The Pedestrian Bicycle Projects and Livable Centers Projects will improve connectivity, build on earlier developments, and help pedestrians and cyclists gain access to transit.

The proposed projects will address some of the shortcomings in transportation and strengthen efforts to build more coordinated and connected transit system. The Pedestrian Bicycle Projects focus on improving pedestrian and bicycle facilities across rail line and increasing safety at rail crossings. The Livable Centers Projects will enhance intersections to make them safer, improve the capacity for multi-modal travel and increase connectivity. Thirty-four percent of residents in the East End use transit, walk or bike to get to work and school. I am pleased to support the Greater East End District's two grant applications for the improved connectivity of mass transit with pedestrians and cyclists and am encouraged that they are not starting from scratch, but will be using these resources to build onto earlier projects.

Currently, 34% of the residents in the East End rely on transit to go to work, school, church and shop for groceries. By improving the aging pedestrian and bicycle transit options, this area will not only be more productive, but safer for those who depend on bicycles and sidewalks to reach the transit system.

While METRO recently invested \$525 million into building the East End light rail system, no major parking lots were constructed along the route, making further improvements to bicycle lanes and sidewalks necessary to protect transit riders as they depart the trains for their ultimate destinations in the East End and to improve both access and safety for commuters as they travel to the area businesses and homes.

Having the privilege of recently being elected as the State Senator for District 6, I have had the benefit of speaking with many of the area's residents personally and have repeatedly been told that reliable, safe access to mass transit is a concern felt by many. The \$5.5 million requested by the Greater East End District directly addresses this concern and is money well spent, as it focuses on connectivity and building onto existing projects, rather than beginning anew.
