1. CALL TO ORDER

Board Chair, Brazoria County Commissioner Stacy Adams called the meeting to order at 11:27 a.m. on Tuesday, December 19, 2023, in H-GAC's Conference Room D at 3555 Timmons Lane in Houston.

2. APPROVAL OF MINUTES FROM MARCH 16, 2021, MEETING

After a cursory overview of the March 16, 2021, minutes, Board Chair Adams called for approval of the minutes. Trustee Owens made a motion to approve the minutes. Council Member Branson seconded the motion. Board Chair Adams called for a vote, which resulted in unanimous approval.

3. STATUS REPORT

Corporation President Chuck Wemple gave an overview of the activities between the previous March 16, 2021, meeting and to the present. Mr. Wemple explained the importance of the corporation and in its non-profit status in helping disperse donated funds. Mr. Wemple stated we had received multiple different donations, including donations from Wells Fargo and Dow Chemical to assist with water quality services. Mr. Wemple discussed the application process and agreements needed for disbursing funds.

4. APPROVAL OF FINANCIAL STATEMENTS

Board Chair Adams called on Secretary/Treasurer Christina Ordonez-Campos to provide a financial report for the Corporation for Regional Excellence. Mrs. Ordonez-Campos presented the financial statement from 1/1/2023 to 11/30/2023. According to the balance sheet Mrs. Ordonez-Campos provided, the corporation had a healthy cash and investment balance of \$1,005,995. Mrs. Ordonez-Campos highlighted a Clean Air Initiatives – CMAQ grant for \$163,633 and the Wells Fargo Water Quality Service grant for \$20,000 of which \$10,703 have been spent. Board Chair Adams asked if the total net investment has grown since their previous meeting. Mrs. Ordonez-Campos addressed the query by stating that the cash balance rolls over each year and accumulates overtime but will investigate the specifics. Board Chair Adams asked how the corporation can spend it down if everything is unrestricted. Mr. Wemple stated that the corporation determines how to spend down and verify that it is unrestricted. Council Member Branson moved to approve the financial statements pending a review by staff. Council Member Arnold seconded the motion. Board Chair Adams called for a vote, which resulted in unanimous approval.

5. ELECTION OF OFFICERS

Board Chair Adams called for nominations to serve as chair and vice chair on the Corporation Board. Council Member Arnold made a motion for Commissioner Adams to serve as Chair. Mayor Garcia made a motion for Council Member Arnold to serve as Vice-Chair. Council Member Branson seconded the motion. Board Chair Adams called for a vote, which resulted in unanimous approval. Mayor Garcia made a motion to appoint H-GAC Executive Director Chuck Wemple to serve as President and H-GAC CFO Christina Ordonez-Campos to serve as Secretary/Treasurer. Council Member Branson seconded the motion. Board Chair Adams called for a vote, which resulted in unanimous approval.

6. MISCELLANEOUS BUSINESS

Board Chair Adams then called upon Mr. Wemple to discuss any other business. President Wemple stated it may be in the best interest of the Corporation for Regional Excellence to meet more frequently and for the next meeting to be held no later than June 2024.

7. ADJOURNMENT

There being no further business, Board Chair Adams adjourned the meeting at 11:46 a.m.
