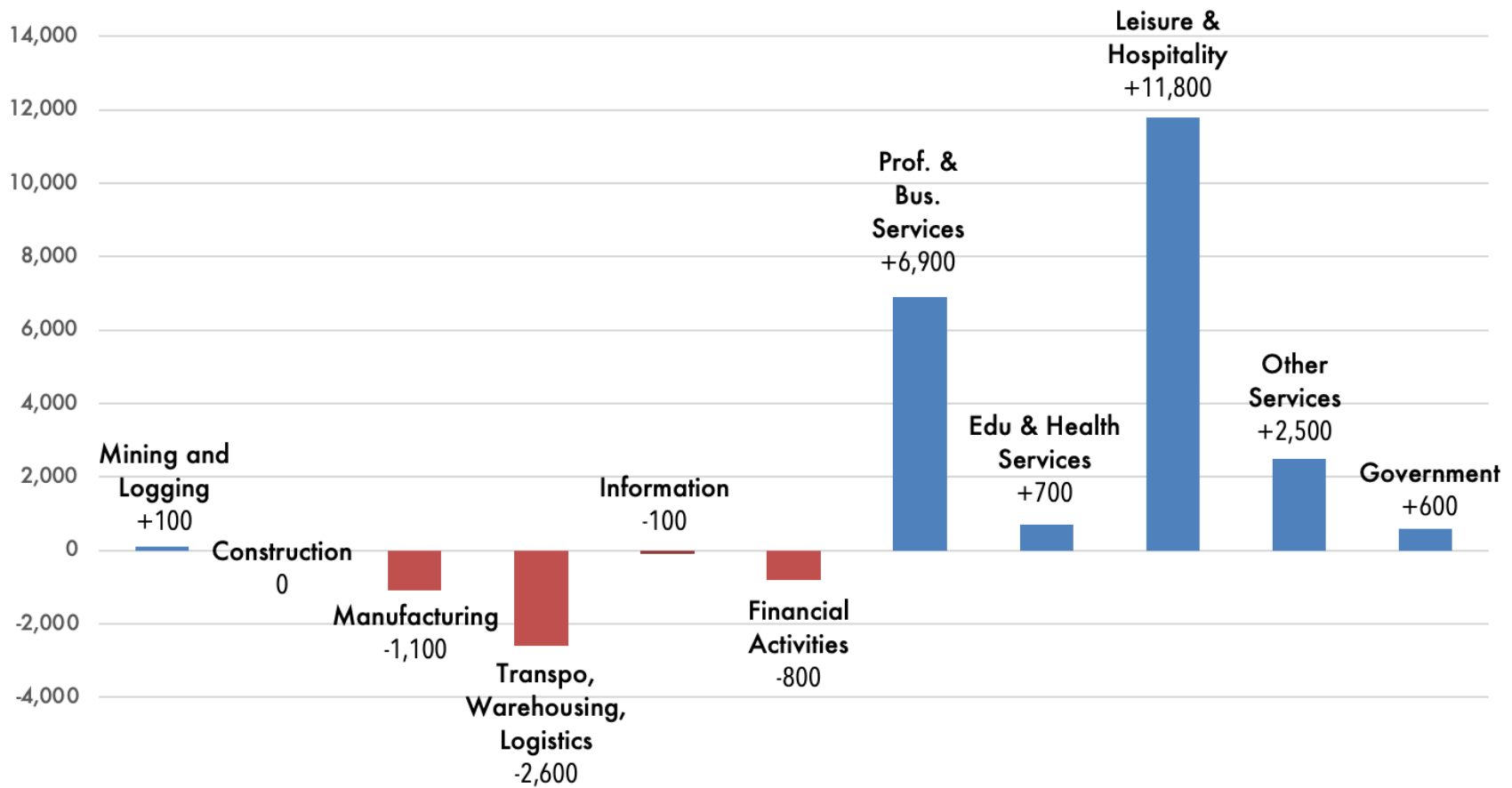

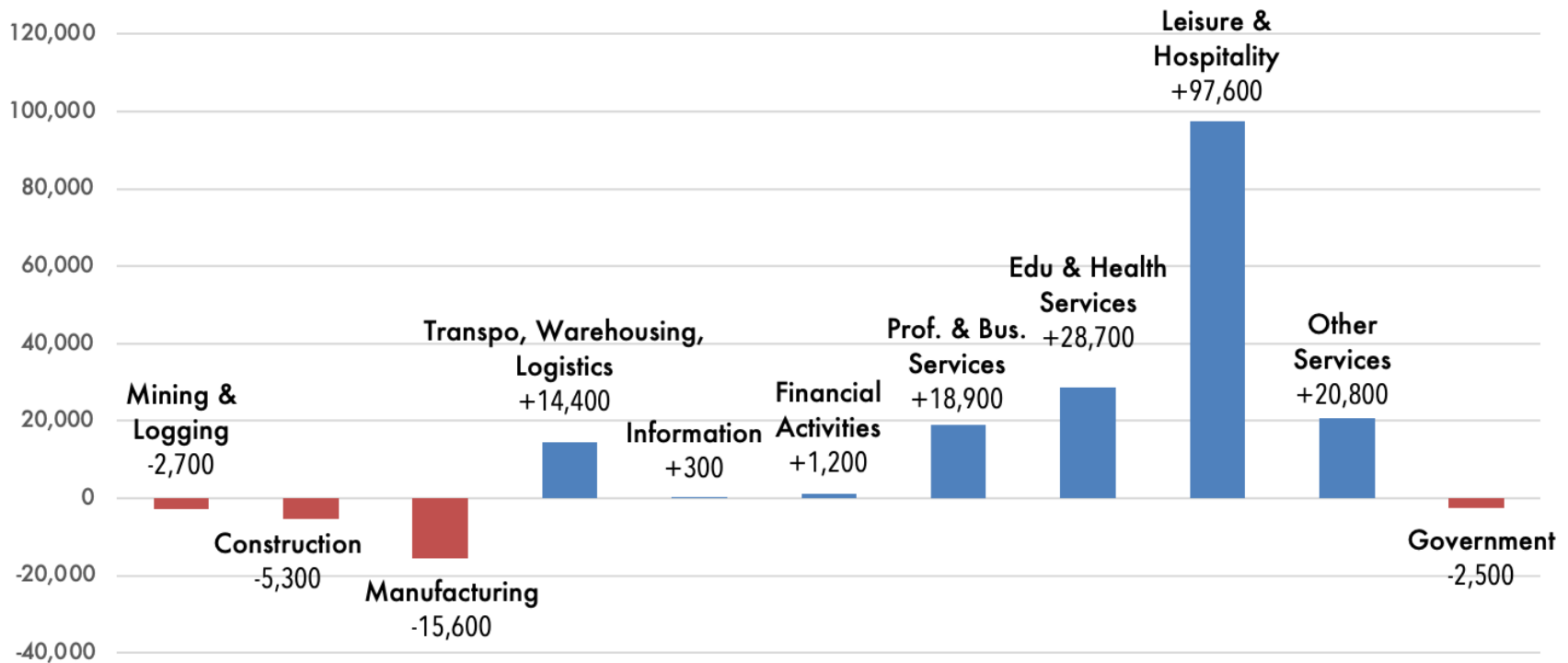
Monthly Change in Employment (000s) for Select NAICS Industries in Houston-Sugar Land-Baytown MSA Mar - Apr 2021

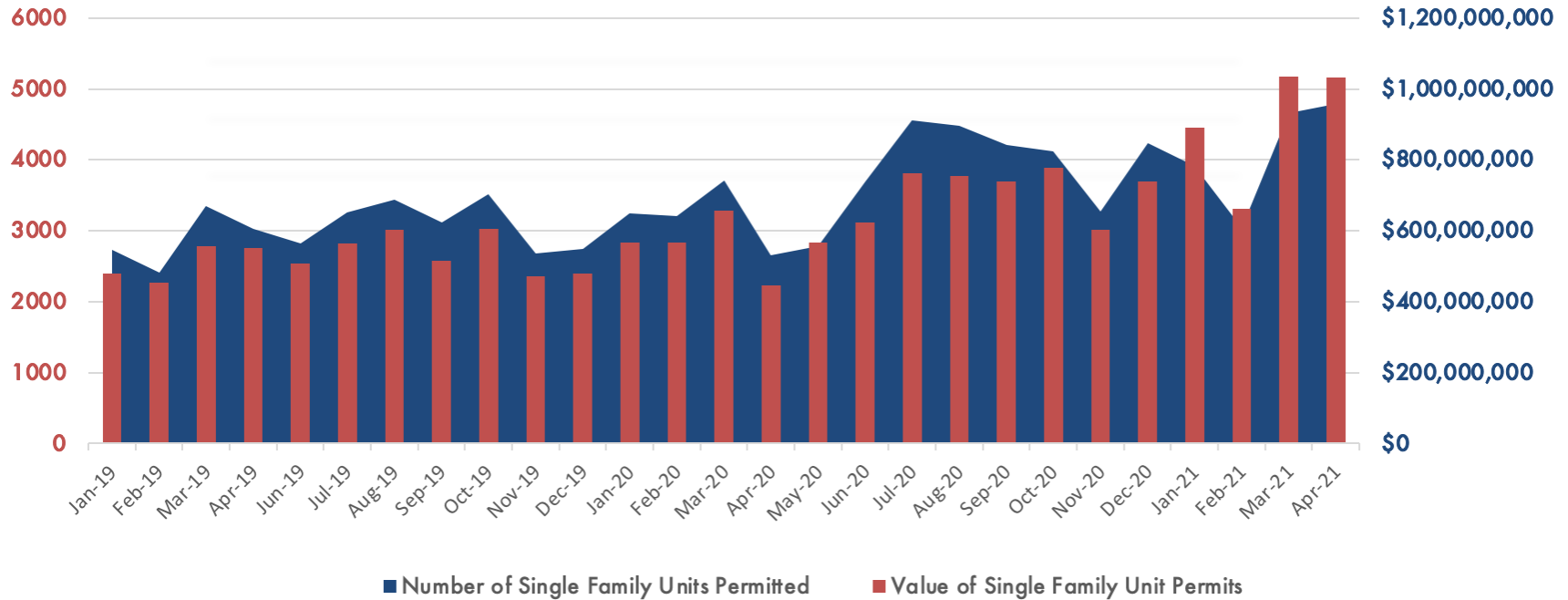
Yearly Change in Employment for Select NAICS Industries in Houston-Sugar Land-Baytown MSA Apr 2020 - Apr 2021

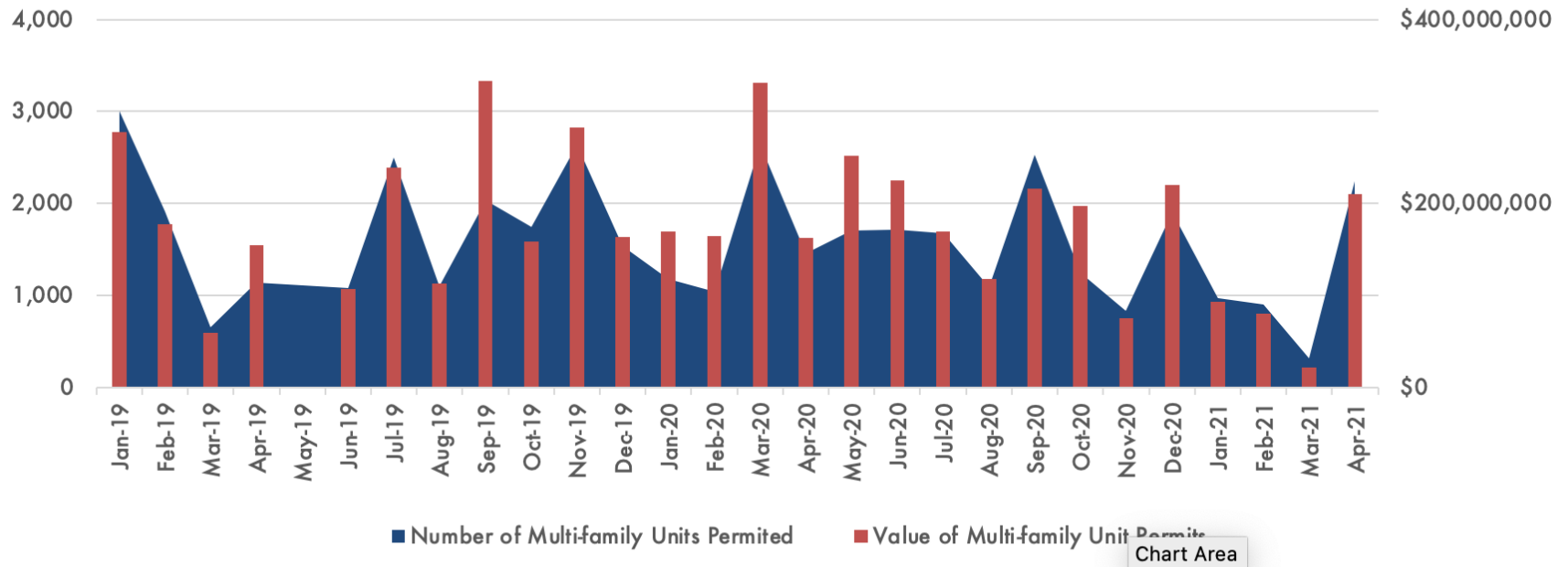

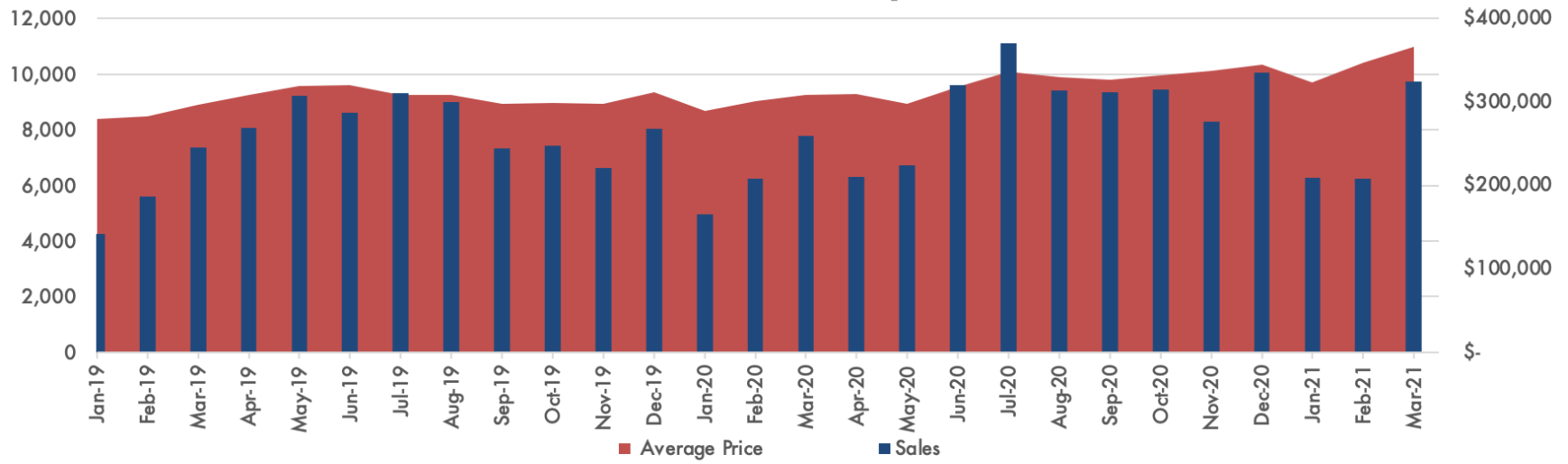
