

## **9. APPROVAL OF RESOLUTION RECOGNIZING SEPTEMBER AS COMMUTE SOLUTIONS MONTH**

### **Background**

Commute Solutions is a travel demand management outreach and marketing program that promotes shifting how, when, where and whether we travel in order to reduce congestion and improve air quality in our region. Commute Solutions is conducted by the Houston-Galveston Area Council, in partnership with the Texas Department of Transportation, regional transportation agencies, area employers and universities, local governments and other community organizations. The program provides planning assistance, education, information, and outreach about transportation options like carshare, bikeshare, walking, bicycling, transit, carpool, vanpool, telework, and compressed work weeks to help us reduce vehicle miles traveled in the region.

Through the Commute Solutions website, [www.yourcommutesolution.org](http://www.yourcommutesolution.org), the program provides valuable information including fact sheets, webinars, infographics, templates, reading lists and maps to share available transit options, best practices for telework, commuting during COVID and much more. The Commute Solutions staff has launched a free partners program offering custom surveys for worksites and origin and destination analysis to help organizations reach goals like reducing parking costs, improving corporate sustainability, and increasing employee retention through improved travel demand management and telework plans.

### **Current Situation**

In celebration of the 27<sup>th</sup> year of the Commute Solutions Program, H-GAC staff is requesting to recognize September 2021 as Commute Solutions Month. During the month, H-GAC staff will: work with area partners to promote behavior shifts through an awareness campaigns targeting congested corridors, conduct appreciation events for those practicing smart travel behaviors and provide virtual consultations for those who may be interested in a shift.



- THIS RESOLUTION IS EFFECTIVE IMMEDIATELY UPON PASSAGE.


