Chair Veronica Chapa-Gorczynski entertained a motion for Consent Agenda Item; 5A.) Meeting Minutes Summary for September 18, 2024, and 5B.) TAC Nominating Committee Recommendations.

A motion to approve was made by Mr. Jason Smith. A second motion for approval was made by Mr. Ken Fickes. The Committee voted and the motion carried.

ITEM 6. ADDITIONAL CARRYOVER SPEND DOWN PROJECTS

Ms. Callie Barnes presented on the Additional Carryover Spend Down Projects. H-GAC monitors the progress of all projects scheduled to let within the 4-year Transportation Improvement Program (TIP) timeframe by conducting quarterly meetings with project sponsors. The meetings are conducted for projects funded with: Congestion Mitigation Air Quality Funds (CMAQ) – Category 5; Surface Transportation Block Grant (STBG) – Category 7, and Transportation Alternative Set Aside (TASA) – Category 9. Discussions during quarterly meetings include project development status, critical path timelines, realistic let dates and upcoming amendments needed (for cost increase requests, let date changes, etc.). H-GAC identified several critical path items for project development taking longer than expected (some causing 1–2-year delays or more). From May 2022-May 2023, H-GAC worked with local government sponsors to identify realistic schedules and let dates for all projects in the TIP. At the May TAC/TPC, the following was presented: 46% (~\$170M) of projects (with Categories 5, 7 and 9) "shifted" from FY 2023 – 2024 and 41% (~\$180M) of projects (Categories 5, 7 and 9) shifted from 2023-2025. The realistic conversations and project shifts resulted in a clearer understanding of the region's growing carryover balances, particularly in Categories 5 and 7.

Staff requested TAC recommendation for TPC approval to spend down Categories 5 and 7 carry over balances as follows:

- Approve concurrence letter (Item 06-04) to move \$20M of CMAQ funds already transferred to FTA for METRO's West Belfort Park & Ride Facility (MPO ID 18017) to Missouri City Park and Ride project so to allow additional CMAQ funding to be programmed on the Missouri City Park and Ride project (MPO ID 18167);
- 2) Move project let dates as described in the paragraph above (Item 06-04);
- 3) Program \$218,392,356 of CMAQ (Category 5) funds with a total project cost of \$269,967,630 (Item 06-05); and
- 4) Program and \$363,261,695 in STBG (Category 7) funds with a total project cost of \$378,265,052 (Item-06-06).
- 5) A list of "E" phase projects for engineering and environmental only (Item 06-07) are still under consideration for funding in FY 2026 or FY 2027. TxDOT Houston District and H-GAC are coordinating in reference on how to handle these additional "E" phase projects under consideration. A motion to oppose was made by Mr. Jason Smith.

After the vote, Ms. Sherry Weesner, wanted to clarify that Item 06-07, "Consider Future Funding of Project, "E" Phase Only, will remain on the list and that the Committee is being asked to approve Item 06-07, to be brought back at a later time for a vote with the completed list of recommendations. Ms. Barnes concurred and mentioned that item 06-07 will be revisited in about 6 months and voted on then.

ITEM 7. 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AMENDMENTS

In this item, two presentations were provided, 7A.) Carryover Spend Down Amendments, presented by Ms. Callie Barnes and 7B.) Additional Transportation Improvement Program (TIP) Amendments, presented by Mr. Jim Dickinson.

ITEM 7A. CARRYOVER SPEND DOWN AMENDMENTS

The 2025-2028 Transportation Improvement Program (TIP) is a four-year capital improvements program for transportation projects. Under federal rules, all federally assisted projects must be included in the TIP to be eligible for funding. In addition, federal rules require that regionally significant local projects must also be included in the TIP.

The 2045 Regional Transportation Plan (RTP) is a long-range plan that prioritizes spending on regional transportation projects including short and long-range strategies to ensure the transportation network is safe and efficient. Updated every four years, the RTP outlines a fiscally constrained transportation investment program that is based on the unique needs and characteristics of the MPO region.

Amendments to the TIP and RTP are brought to the Transportation Policy Council for consideration monthly and amended in accordance with the H-GAC Public Participation Plan.

Ms. Callie Barnes requested the following TAC recommendations for TPC approval: 1) To fund all projects listed in items 06-05 with CMAQ; 2) Fund all projects listed in items 06-06 with STBG; 3) Consider future funding of project in item 06-07 for "E" phase only; 4) Approve METRO's FTA project scope change request; and 5) Shift let dates in Item 07A-02.

ITEM 7B. ADDITIONAL TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AMENDMENTS

Mr. Jim Dickinson presented a summary of the proposed revisions to the Transportation Improvement Program and the 2045 Regional Transportation Plan included below:

- Revise thirty-two (32) TXDOT Houston District projects to reconcile their funding in Categories 2, 3-Design Build, 4, 12-Texas Clear Lanes, and Statewide Right of Way with the 2025 Unified Transportation Program approved by the Texas Transportation Commission in August 2024. Added after September meeting:
 - IH 69 S Reconstruct & Widen (MPO ID 7428) +\$133M Cat-4
 - IH 10 W Reconstruct & Widen (MPO ID 10334) + \$111M Cat-2 & \$111M Cat-4
 - IH 10 W Restripe & Widen (MPO ID 13864) +\$773K Cat-4

- Revise the funding of five (5) TXDOT Houston District projects in Categories 2, 3, 4, and Statewide Right-of-Way due to design changes and a new primacy agreement between Brazoria County and TXDOT. Also, clarify the limit of SH 99 Segment B construction (MPO ID 257) due to the design change. Added after September meeting:
 - Program two (2) City of Galveston/Island Transit FTA Section 5339 vehicle purchase projects in FY 2025 & FY 2026 (MPO IDs 19180 & 19181) +\$360K

Mr. Dickinson also provided a table that showed funding categories involved in the Unified Transportation Program (UTP) adjustments and a map of the roadway projects for UTP and SH 99 that illustrated distribution of the TxDOT projects throughout the region.

After the presentation, Chari Chapa-Gorczynski opened the floor for questions. Ms. Sherry Weesner recommended that Staff provide a presentation on rules and guidelines for amendments at the next upcoming TAC Meeting. Staff will accommodate the request to present the rules and guidelines (Public Participation Plan) in an upcoming TAC meeting.

Mr. Jason Smith made a motion to approve the amendments. A second motion for approval was made by Ms. Catherine McCreight. The Committee voted and the motion carried.

ITEM 8. CYCLE 7 FY2025-2028 LIVABLE CENTERS PROGRAM STUDIES

Ms. Sarai Osorio presented on the Cycle 7 FY2025-2028 Livable Centers Program Studies. The Livable Centers Program, administered by H-GAC since 2008, encourages a complementary mix of land uses that are designed to be walkable, connected, and accessible by multiple modes of transportation, including bus, bike, or walking. Livable Centers are defined as places where people can live, work, and play with less reliance on their cars. H-GAC and our local partners work with communities to identify a vision for the study area and make specific recommendations, such as pedestrian and bicycle facilities. Similarly, proposed policies and programs aim to promote economic development while cultivating a sense of identity within study areas.

H-GAC issued a competitive call for study partners in February 2024. Staff received 19 notices of intent to apply and a final 17 application submissions from 15 entities. Staff convened a five-person evaluation committee comprised of H-GAC staff, Texas Department of Transportation staff, and past study partners to evaluate and rank applications based on H-GAC criteria. Based on the committee's evaluations, thirteen studies are recommended to receive \$3,170,000 in Transportation Planning Funds for studies. Ten are recommended to be funded as Livable Centers studies and three as Focused Livable Center studies. To hear further details on this presentation, please click on the link below.

ITEM 9. PROJECT SELECTION PROCESS

Mr. Vishu Lingala provided an update on the Project Selection Process At the March 2020 Transportation Policy Council (TPC) meeting, the Council approved goals, priorities, and policies for selection and prioritization of projects to be programmed in Transportation Improvement Program (TIP), 10-Year Plan, and the Regional Transportation Plan (RTP). These goals, priorities and policies guide the H-GAC staff, Transportation Advisory Committee (TAC), and the TIP Subcommittee in development of project selection criteria and evaluation methodologies for project planning and programming. At the January 2023 meeting, TPC authorized the MPO staff to initiate the Project Selection Process.

Staff completed the review of benefit cost analysis (BCA) submitted by the sponsors and are currently in the process of validating the benefit cost ratios. After the benefit cost ratios are validated by the sponsors, staff will assign BCA scores to the projects and publish the total scores and ranking of the projects in the following five investment categories.

- Major Projects
- High Growth Area Needs
- Operational Improvements and Congestion Management
- Resiliency and State of Good Repair
- Transit

ITEM 10. 2025 UNIFIED PLANNING WORK PROGRAM UPDATE

Ms. Allie Isbell gave an update on the 2025 Unified Planning Work Program. The Unified Planning Work Program (UPWP) is a required document describing all anticipated planning activities for the Metropolitan Planning Organization; It includes a description of tasks and budgets for the Federal Fiscal Year (October 1 to September 30). The UPWP describes the regional transportation plans and programs carried out in the eightcounty Metropolitan Planning Area:

- Development of all required planning products or activities (primarily the Regional Transportation Plan, Transportation Improvement Program, Congestion Management Process, etc.);
- Continuous and one-time planning activities related to safety, freight, transit, subregional areas, corridors, active transportation, air quality, data and modeling, and livable centers; and Special planning activities (e.g. Safe Streets and Roads for All and PROTECT resiliency planning).

Ms. Isbell provided a high-level overview of ongoing key activities for the FY2025 UPWP Mobility/Thoroughfare Plans and Studies, Active Transportation, and Transit with the anticipated completion dates. Ms. Isbell further described that the studies were being mapped out by Staff, according to the recommendations from 2012 to 2024 and that Staff created a database with the list of recommendations, with GIS information for all studies. Next Steps were provided to the Committee which included the following: Incorporate TAC and TPC involvement into plan finalization; Publish recommendations database map; and develop guidance for accepting new study requests. ITEM 11. MPO STRATEGIC HIGHWAY NETWORK ADDITIONS CONCURRENCE

Ms. Allie Isbell gave an update on the MPO Strategic Highway Network Additions Concurrence. The Strategic Highway Network (STRAHNET) is a network of highways which are important to the United States' strategic defense policy, and which provide defense access, continuity, and emergency capabilities for defense purposes.

To ensure that defense important roadways were being considered as part of the U.S. Department of Transportation's (USDOT) strategic plan, the Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA) and the National Highway System Designation Act of 1995 provided for the inclusion of STRAHNET and STRAHNET Connectors into the National Highway System (NHS). Federal oversight will help ensure optimum maintenance levels for the NHS, thus assuring that the roads can support a military deployment. Source: FHWA website and the STRAHNET Atlas.

TxDOT and the Department of Defense (DoD) have been coordinating the addition of 17 existing roadway locations to the Strategic Highway Network (STRAHNET) as part of the DoDs efforts to improve connectivity between Fort Bliss and Fort Cavazos and their designated seaports of embarkation in Port Beaumont and Port Arthur. An updated list was provided of existing facilities that were being proposed as part of these STRAHNET additions along with the updated location maps. TxDOT is in the process of recreating these location maps using the Texas Projects and Programming Division (TPP) map template to standardize the map details and roadway locations.
