ITEM 6. AMENDMENTS TO THE 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AND THE 2045 REGIONAL TRANSPORTATION PLAN (RTP), MR. JIM DICKINSON, H-GAC

Mr. Jim Dickinson, H-GAC, provided a presentation on the Amendments to the 2023-2026 Transportation Improvement Program (TIP) and the 2045 Regional Transportation Plan (RTP). A summary of the proposed revisions to the 2023-2026 TIP and 2045 RTP are included below:

- Program the TxDOT Houston District's SH 99 Segment B direct connectors construction project at SH 35 in Brazoria County (MPOID 8088) in FY 2026 with state toll funding and federal right-of-way funding. (+\$88.4M)
- Program the City of Houston's \$21.0M federal Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant for the rehabilitation of Telephone Road (MPOID 18933) in FY 2024. It will be matched with local funds. (+\$26.2M)
- Change the sponsor of the SH 99 Segment B direct connectors at IH 45 South construction project (MPOID 14249) from Galveston County to TxDOT Houston District. Delay it from FY 2025 to FY 2026 with increased state toll construction funding and \$4M of federal right-of-way (ROW) funding. Add ROW as an authorized phase of work. (+\$69.9M; Total Cost: \$145.9M)
- Delay TxDOT Houston District's SH 99 Segment B-1 construction project in Galveston County (MPOID 283) from FY 2025 to FY 2026 to coordinate its construction letting with other projects on the corridor and increase the state toll construction funding to cover the latest estimates for materials. (+152.6M; Total Cost: \$409.6M)

- Delay TxDOT Houston District's SH 99 Segment B construction project in Brazoria County (MPOID 257) from FY 2025 to FY 2026 to coordinate its construction letting with other projects on the corridor. (Total Cost: \$203.1M)
- Delay TxDOT Houston District's SH 35 main lanes and grade separations construction project in Brazoria County (MPOID 18027) from FY 2024 to FY 2026 to coordinate its construction letting with other projects on the corridor. (Total Cost: \$39.4M)
- Delay the City of Houston International Management District's Transportation Alternatives Set-Aside (TASA) funded bikeway construction project (MPOID 17120) from FY 2024 to FY 2026 to allow time to finalize the Advanced Funding Agreement with TxDOT Houston District. (Total Cost: \$2.6M)
- Delay the City of Houston's Surface Transportation Block Grant (STBG) funded Fondren Road reconstruction project (MPOID 17093) from FY 2024 to FY 2026 to allow time to finalize its design changes. (Total Cost: \$25.5M)
- Delay the City of Pearland's Mykawa Road STBG funded widening project (MPOID 17082) from FY 2023 to FY 2026 due to ongoing ROW and utilities relocation issues. (Total Cost: \$39.0M)
- Delay the City of Pearland's Mykawa Road STBG funded widening project (MPOID 7602) from FY 2024 to FY 2026 to continue ROW acquisitions. (Total Cost: \$2.9M)
- Delay the City of Pearland's Smith Ranch Road STBG funded widening project (MPOID 11654) from FY 2023 to FY 2024 to continue ROW acquisitions and utilities relocations. (Total Cost: \$4.9M)
- Delay the City of Tomball's Metropolitan and Urban Area Corridor Projects (Category 2) funded FM 2920 reconstruction project (MPOID 17085) from FY 2025 to FY 2026 to allow time to finalize the public involvement process and design revisions. (Total Cost: \$28.6M)
- Delay Fort Bend County's Congestion Mitigation/Air Quality (CMAQ) funded Wireless Traffic Signal Communication System construction project (MPOID 17062) from FY 2024 to FY 2025 due to environmental technical report developments. (Total Cost: \$9.3M)

ITEM 7. PAVEMENT & BRIDGE PERFORMANCE MEASURES, MS. KAREN OWEN, H-GAC

Ms. Karen Owen, H-GAC, provided a presentation on the Pavement and Bridge Performance measures. Ms. Owen informed the Council the Federal Measures are focused on the National Highway System what we refer to the as (NHS) on the Pavement side the measures are in two subsets. Ms. Owen presented a map to the Council that illustrated The Interstate highlighted in red and Non-Interstate highlighted in black (Beltway 8, US 290 and Highway 105.) H-GAC has a responsibility of setting regional targets in the 8-County area. Ms. Owen described the Performance Measures and Targets and discussed the process on setting targets, she also presented and described the targets met and not met. Ms. Owen told the Council that there are no penalties for missing the targets. Ms. Owen provided information on H-GAC analysis of regional data sets and described agency coordination, past and future pavement conditions for interstate and non-interstate, bridge conditions, regional investments by category, setting future targets, and staff recommendations for future targets. Ms. Owen concluded her presentation with a timeline for Pavement and Bridge Performance Measure approval. Ms. Owen requested approval of the Pavement & Bridge Performance Measures and TPC Resolution No. 2023-27. A question-and-answer period occurred after the presentation among TPC member and H-GAC Staff. A motion was made by Mayor Kevin Cole and seconded by Judge Mark Keough. The Council voted and TPC Resolution No. 2023-27 was approved.

ITEM 8. UNIFIED PLANNING WORK PROGRAM (UPWP) AMENDEMENT, MR. CRAIG RABORN, H-GAC

Mr. Craig Raborn, H-GAC provided a presentation on the Unified Planning Work Program and informed the Council the UPWP is two-year plan, that runs from October 1, 2021-September 30, 2023 and described regional transportation planning activities and programs. The current UPWP was adopted by the Transportation Policy Council (TPC) on August 27, 2021 and most recently amended on February 24, 2023. Mr. Raborn described the amendment to be added to Task V, Sub-Task 5.2. to the Council as follows:

- 1. Task V, Sub-task 5.2 Corridor, Technology, and Special Studies [Amendment Action: Add activity and document partner funding grant] [Partner Special Study] City of Houston "Gulfton and Beyond" planning grant:
 - The City of Houston received an FHWA Reconnecting Communities Discretionary Grant for FY2023 to conduct a planning study to examine connections between Hillcroft Avenue in Gulfton and destinations including Hillcroft Transit Center, Wisdom High School, and Bray's Bayou, that are currently separated by infrastructure, including Southwest Freeway, Westpark Tollway, and other busy roads.
 - The grant is for \$552,160 of discretionary grant funds, with a local match of \$138,040 provided by the City of Houston. The total project amount will be \$690,200. (These FHWA grant funds are not reflected in the UPWP Funding Tables because the work will be conducted by a partner agency.)

Mr. Raborn requested approval of the Unified Planning Work Program and UPWP Resolution No: 2022/23-8. A motion was made by 1st Vice Chair Justin Beckendorff and seconded by Mayor Kevin Cole. The Council voted and approved the amendment to the UPWP and approved UPWP Resolution No: 2022/23-8.

ITEM 9. PROJECT SELECTION PROCESS UPDATE, MR. ADAM BECKHOM, H-GAC

Mr. Adam Beckom, H-GAC, provided a presentation on the Project Readiness Questionnaire and described H-GAC staff efforts to spend down carry-over balances. Mr. Beckom informed the Council that Project Readiness questionnaires were sent out to over 230 sponsors and were sent to agencies that indicated their projects were ready for construction in 0-3 years. The agencies have 3 weeks to return the questionnaire. Mr. Beckom also informed the Council that agencies would only need to fill out questionnaire once. Mr. Beckom described the Regional Goods Movement investment category and staff would focus on those first and informed the Council that 88 projects were submitted and 24 were over \$100 M and would move on the major project selection and 64 projects were less than 100 M and were scored through this effort. Mr. Beckom concluded his presentation with draft RGM projects, next steps and timeline.

ITEM 10. 2024 UNIFIED PLANNING WORK PROGRAM, (UPWP), MR. CRAIG RABORN, H-GAC

Mr. Craig Raborn, H-GAC, provided a presentation on the draft 2024 Unified Planning Work Program. Mr. Raborn informed the Council about the current UPWP progress status and described the activities completed, activities underway, under procurement, under development and 12 planned activities will carryover. Mr. Raborn also described delays with some funding agreements, procurements and staffing shortages. The 2024 UPWP will be a one-year rather than two-year program and will focus on completing carryover tasks. Mr. Raborn further elaborated the UPWP will incorporate the new Bipartisan Infrastructure Law requirements, have an approximately \$12.5 million planned budget, have significant reformatting and restructuring and there will be opportunities to add activities or studies through amendment. Mr. Raborn described specifics tasks and activities under those tasks, budget, funding sources and timeline for TPC approval.

ITEM 11. AIR QUALITY CONFORMITY STATUS UPDATE, MR. CRAIG RABORN, H-GAC

Mr. Craig Raborn, H-GAC, provided an update to the Council on the Air Quality Conformity Status and informed the Council that the Air Conformity is required by Federal law and demonstrates that projected emissions from transportation projects are within emission limits (Motor Vehicle Emissions Budgets) established by the State Implementation Plan (SIP) and ensures federal funding and approval is applied to transportation projects that are consistent with air quality planning goals. Air Conformity is triggered by adoption of new Regional Transportation Plan (RTP) or Transportation Improvement Program. (TIP) A new RTP and TIP must be found to conform before being accepted by the U.S. Department of Transportation. Previous Regional Transportation Plan approved by FHWA August 2, 2019 and the Conformity expires August 2, 2023. The new Regional Transportation Plan and Conformity Determination approved by TPC on April 28, 2023 and FHWA Conformity determination needed by August 2, 2023 to avoid going into the this grace period. Mr. Raborn continued his presentation by informing the Council that all initial documentation submitted 90 days before deadline. Also, staff has responded to all comments from EPA, TCEQ, and TxDOT and partners prepared to route Conformity Determination letters. Staff is waiting for comments FHWA and responses usually take 1-2 days. If the deadline is reached without conformity, the region enters "Conformity Lapse Grace period. Staff was notified informally that deadline will not be met. Mr. Raborn concluded his presentation with a timeline, an overview about the basics of lapse grace period, and key take-aways.
