### **PRESENTATIONS**

Tom Stephenson, Community Technology Advisor for Connected Nation, summarized Connected Texas' work with communities in the GCEDD region, including recommended actions related to trends in local online shopping and teleworking in light of COVID-19. Mr. Stephenson provided an overview of the Rural Digital Opportunity Fund (RDOF) Phase I preliminary winners in the GCEDD region and previewed the RDOF Phase II auction, which will allow bids for partially served areas.

Juliana Garaizar, Launch Director for Greentown Labs-Houston, explained the model Greentown Labs uses to engage corporate partners and incubate startups in cleantech industries. With their impending expansion into the City of Houston, Greentown Labs aims to catalyze the energy transition in Houston and the surrounding region.

## Discussion of End-of-Year Survey Results

The Board heard from Jillian Donatto on the End of Year Survey summarizing responses on the impacts of COVID-19 and outlook for recovery. Board members identified a wide range of areas for potential collaboration and partnerships. The board discussed the year ahead, including actions identified in the Comprehensive Economic Development Strategy Action Plan. It was decided that volunteers from the board would meet before the April Board meeting to update the CEDS action plan for the upcoming 12-18 month period.
