The presiding officer, Chair Justin Beckendorff called the Transportation Policy Council (TPC) meeting of September 27, 2024 at 9:30 a.m. to order.

CERTIFICATION OF QUORUM, INTRODUCTIONS AND CONFLICT OF INTEREST

Chairman Justin Beckendorff recognized Ms. Allie Isbell, H-GAC, for the Certification of the Quorum and she conducted the Roll Call of the TPC membership. Fifteen (15) members comprise a quorum. A quorum was declared present and recorded on the Roll Call, which is included with these Minutes as Attachment 1. Chairman Justin Beckendorff asked members of the Council to Declare Conflicts of Interest on any item on the agenda. No TPC member declared a conflict of interest. ITEM 4. PUBLIC COMMENTS

Ms. Jamila Owens provided instructions on how to provide public comment on the Zoom link posted on the H-GAC livestream. Ms. Owens proceeded to let the public know that Spanish translation services where available and introduced Ms. Susana Dahdah who provided instructions on how to make public comments in Spanish. American Sign Language Interpretation services were posted on a slide in Zoom and provided by Rpbert Helms and Mark Riddle. No written comments were received by 5:00 p.m. September 26, 2024. ITEM 5. MPO DIRECTOR REPORT AND ORIENTATION OF AGENDA, MS. ALLIE ISBELL, H-GAC

A. Planning Activities Report

Ms. Allie Isbell, H-GAC, informed the Council that both MPO Assistant Directors (Allie Isbell and Jamila Owens) would share duties until a new MPO Director was in place. Ms. Isbell gave a brief recap of highlights on the planning activities report

B. H-GAC Board Update

No Transportation items on the H-GAC Board in September

C. Project Selection Update

Mr. Vishu Lingala, H-GAC, provided an update on Project Selection and gave the Council a brief update on the Project Selection Process. Mr. Lingala informed the Council in the five investment categories; completed validating all evaluation scores. Benefit Cost Analysis and Project Readiness were submitted online by August 30, 2024. Will provide draft total scores of projects by October 16th TAC meeting. Mr. Lingala concluded his update with a summary of draft scores for investment categories, available funding by investment categories and a timeline for the Project Selection Process which is anticipated for approval in November 2024.

D. RTP Project Development Update

Mr. Stephen Keen, H-GAC, informed the Council the application date closed on Wednesday, August 7, 2024. 99 projects submitted. Approximately \$11.6 billion with 12 sponsors. Staff is working on meeting timeline. New fiscally constrained RTP project list expected for preview in November. Mr. Keen provided next steps and a tentative timeline for a December approval.

E. Solicitation for future Carryover Spend down Projects

Ms. Callie Barnes, H-GAC, informed the Council that in December 2023 staff programmed 60 projects with 25 sponsors for a total of \$335M. Projects will either let or transfer to FTA by August 2025. If all projects are successful, they will generate \$23M for the Regional Strategic Transportation Fund program. One project has let from TxDOT Houston for \$21M and two projects has transferred to FTA for Fort Bend County Transit for \$3.7M. Ms. Barnes presented a chart of remaining roadway and transit projects and gave specifics regarding those projects. Ms. Jamila Owens, H-GAC concluded the presentation with a recap of a meeting held with staff and TxDOT Houston district and TxDOT Projects and Programming Division on September 18, 2024. Discussion included Carryover Balances and Allocations, Progress with spending, and FY 2025 is first year of 16.154 State Law changes, a summary of their discussion, an anticipated timeline and next steps.

Chair Justin Beckendorff read the resolution recognizing the service of outgoing TPC Member Mr. David Douglas, Economic Development Director, Liberty County. A motion by Commissioner Adrian Garcia and seconded. The Council voted and approved TPC Resolution No. 2024-27. Chair Beckendorff thanked Mr. Douglas for his service to the TPC and to the Houston-Galveston region.

Chair Justin Beckendorff read the resolution recognizing the service of outgoing TPC member Ms. Eliza Paul, P.E, TxDOT District Engineer to the Transportation Policy Council. Kind words of appreciation by TPC members were provided commending Eliza's for her service to TxDOT and the Houston-Galveston region. Ms. Allie Isbell, H-GAC, informed the Council that Chair Justin Beckendorff requested the TPC rescind a previous action on the Unified Planning Work Program Amendment (UPWP 2024-01) due to the confusion surrounding action taken at the August TPC Meeting. Mr. Wemple also informed the Council that he will meet with Transportation staff in series of small meetings in the next two or three weeks to learn what they think is important in the next Director. ITEM 11. AMENDMENTS TO THE TEXAS DEPARTMENT OF TRANSPORTATION STATEWIDE SAFETY PROGRAM, THE 2025-2028 TRANSPORTAITON IMPROVEMENT PROGRAM AND THE 2045 REGIONAL TRANSPORTATION PLAN, JIM DICKINSON, H-GAC

Mr. Jim Dickinson, H-GAC gave a presentation of the proposed revisions to the Texas Department of Transportation Statewide Safety Program is included below for the Council's review.

- Add \$1.8M of federal Surface Transportation Block Grant (STBG) funding to the Houston-Galveston Area Council's Regional Freeway Incident Management project (MPO ID 11917) to fund continuing towing operations. An additional 352K Transportation Development Credits (TDCs) will be programmed in lieu of matching funds.
- Add \$3.1M of federal STBG funding to the Houston-Galveston Area Council's Regional Freeway
 Incident Management project (MPO ID 17020) to fund continuing towing operations. An additional
 616K TDCs will be programmed in lieu of matching funds.

A summary of the proposed revisions to the 2025-2028 Transportation Improvement Program is included below.

- Program fourteen (14) Gulf Coast Transit District Federal Transit Administration (FTA) Urban Area Formula (Section 5307) funded preventative maintenance and operations projects in FY 2025 with FY 2021-2024 apportionments with 5.7M TDCs in lieu of matching funds.
- Program ten (10) Gulf Coast Transit District FTA Bus and Bus Facility Program (Section 5339) funded bus replacement and maintenance, and bus and facility camera purchases in FY 2025 with FY 2021-2024 apportionments with 325K TDCs in lieu of matching funds.
- Program four (4) Woodlands Township FTA Bus and Bus Facility Program (Section 5339) funded bus and trolley acquisition purchases in FY 2025 with FY 2019-2025 apportionments with 280K TDCs in lieu of matching funds.
- Program three (3) METRO FTA Section 5307 State-of-Good-Repair, Metrolift ADA support and safety & security projects in FY 2025 with FY 2023 apportionments.
- Program one (1) METRO FTA Section 5337 State of Good Repair Fixed Guideway project in FY 2025 with a FY 2023 apportionment.
- Revise the funding of six (6) Woodlands Township FTA Section 5307 funded capital, planning and
 operating projects in FY 2025 with FY 2020 and 2021 apportionments in anticipation of the approval
 of 1.5M TDCs to be used in lieu of matching funds.
- Revise the funding and matching TDCs of one (1) Woodlands Township FTA Section 5339 funded bus
 acquisition and facilities project in FY 2025 with a FY 2023 apportionment based on the actual
 allocation.
- Revise the funding and matching TDCs of two (2) Harris County Transit FTA Section 5307 funded planning and operating projects in FY 2025 with a FY 2022 apportionments based on the actual allocations.
- Advance METRO's FTA Section 5339 bus replacement and fueling facility project from FY 2026 to FY 2025 at METRO's request.

Mr. Dickinson requested approval of TPC Resolution No. 2024-29 and TPC Resolutions No. 2024-30. A motion was made by Commissioner Lesley Briones and seconded by Commissioner Adrian Garcia. ITEM 12. CARRYOVER SPEND DOWN ADDITIONAL PROJECTS, CALLIE BARNES, H-GAC

Ms. Callie Barnes, H-GAC, gave a presentation on 8 projects with 8 sponsors (2 new sponsors) 6 of the projects were brought before the Council in July for action. Two projects have new sponsors and the additional requested amount from Carry Over Spend down is \$65,100,000. If these projects are successful, they will generate \$5,500,000 in the Regional Strategic Transportation Fund. Five projects are programmed as FTA Transfers, one project is programmed for "E" Phase (Eng/Env) and one project is programmed for "C" phase (Construction.) Ms. Barnes described a table listing all projects with August 2025 let date and described the next steps in the process. Ms. Barnes conclude her presentation by requesting TPC approval of Resolution No. 2024-31 and 2024-32. A comment period by TPC members occurred after the presentation. A motion was made by Council Member Sallie Alcorn and seconded by Mayor Kevin Cole. The Council voted and approved TPC Resolution No. 2024-31 and TPC Resolution No. 2024-32. ITEM 13. RELIABILITY, CONGESTION, AND AIR QUALITY PERFORMANCE MEASURE UPDATE, KAREN OWEN, H-GAC

Ms. Karen Owen, H-GAC, presented on the Reliability, Congestion, and Air Quality Performance Measures. Ms. Owen informed the Council on the Federal measures that are focused on the National Highway System and described a map that illustrated the interstate and the non-interstate national highway system. These measures are for Reliability, which is personal and truck travel, Congestion measures of peak hour excessive delay, and non-Single occupant vehicles, and Air Quality which is tailpipe emission reductions from Congestion Mitigation Air Quality (CMAQ) projects. Ms. Owen described the data gathered by staff. the results and future measures. There are no penalties for missing the targets. Ms. Owen requested approval of TPC Resolution No. 2024-33. A motion was made by Jon Branson and seconded by Commissioner Adrian Garcia. The Council voted and approved TPC Resolution No. 2024-33. ITEM 14. 2024 LANGUAGE ACCESS PLAN UPDATE, AYO JIBOWU, H-GAC

Mr. Ayo Jibowu, H-GAC, gave a presentation on the 2024 Language Access Plan Update. Mr. Jibowu informed the Council the Houston-Galveston Metropolitan Planning Area is one the most diverse in United States. Of 7.1 million residents, over 1.2 million are identified as Limited in English Proficiency (LEP) Title VI of the Civil Rights Act of 1961, E.O. 13166 facilitates meaningful access to H-GAC's programs and activities for stakeholders with limited English proficiency. Mr. Jibowu described a slide with the LAP contents and highlighted Oral Language Services (Interpretation) and Written Language Services (Translation of Vital Documents) and described H-GAC's Public Participation activities. This update is required every three years. H-GAC receives federal transportation funds through the FTA and FHWA. Title VI Program was last updated in 2021. Mr. Jibowu highlighted some of the topics that are required to be in compliance and a demographics map. - Revise the funding of five (5) TXDOT Houston District projects in Categories 2, 3, 4, and Statewide Right-of-Way due to design changes and a new primacy agreement between Brazoria County and TXDOT. Also, clarify the limit of SH 99 Segment B construction (MPO ID 257) due to the design change.
