The District's grant-funded capital program focuses on connecting neighborhoods and business to transit and resulted in \$31 million in improvements through 2017, with an additional \$45 million in new investments pending during her tenure.

A native of the Rio Grande Valley, educational and job opportunities have taken Veronica to live in San Antonio, New Orleans, Washington DC, Austin, and now Houston. She has worked in government, non-profit organizations, and education efforts—always focusing on ways to help the community gain resources and investment.

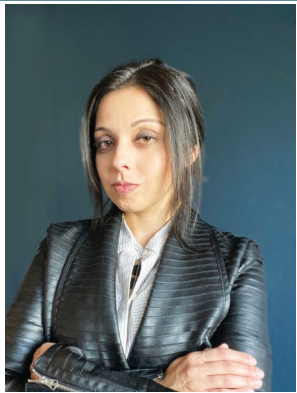
**Selina Valdez,

Selina is the first Recycling Coordinator for the East Aldine Neighborhood Depository and Recycling Center. The idea of a Recycling Center was created by the Board of Directors of the East Aldine

Management District, and she was chosen to turn that idea into a reality. Selina was instrumental in connecting the recycling vendors to the management district and overseeing the contract negotiations to the satisfaction of all parties. As the coordinator, she is responsible for hiring and training staff while creating a work environment that promotes safety, best customer service practices, and encourages life-work balance.

Selina’s leadership style was shaped by her vast work experience, including a stint in the United States Marine Corps, working as a Human Resources Safety Officer in Paris, Texas. Marcus Martinez, Partner UltraBarrio

Marcus is a Partner at UltraBarrio where he is dedicated to topics that foster resilient communities, repurposing infrastructure, and building types that relate to cycles of scarcity, surplus, and obsolescence. His lens on these cycles

was shaped as a collaborator focusing on mobility at the Massachusetts Institute of Technology (MIT) Media Lab Changing Places group. His efforts there translated into numerous urban core projects in Boston, including the 2024 Olympic Plan – smart city blueprint. His work in established communities like the East End, Near Northside are immersed in culture, legacy, and site performance.

He has received numerous awards, including the preservation award for the Ironworks in the East End, the repurposed Houston freeway – The Pierce Skypark, and state and local American Institute of Architects (AIA) awards for his design and engagement work in Gulfton. Marcus received his Master’s in Architecture and Urbanism from MIT, and has been a thesis instructor at Boston Architectural College, held academic appointments at MIT, and today is a lecturer and studio instructor at the University Houston. He has been an invited critic at Rice University, Wentworth Institute, University of British Columbia School of Architecture + Landscape Architecture, and University of Colorado Denver.

National Highway Performance Program (NHPP)

The NHPP provides support for the condition and performance of the National Highway System (NHS), for the construction of new facilities on the NHS, and to ensure that investments of Federal-aid funds in highway construction are directed to support progress toward the achievement of performance targets established in a State's asset management plan for the NHS.

Surface Transportation Block Grant Program (STBG)

The Surface Transportation Block Grant program (STBG) provides flexible funding that may be used by States and localities for projects to preserve and improve the conditions and performance on any Federal-aid highway, bridge and tunnel projects on any public road, pedestrian and bicycle infrastructure, and transit capital projects, including intercity bus terminals.

Community Development Block Grants (CDBG)

The CDBG entitlement program allocates annual grants to larger cities and urban counties to develop viable communities by providing decent housing, a suitable living environment, and opportunities to expand economic opportunities, principally for low- and moderate- income persons. Bicycle and pedestrian facilities are eligible uses of these funds.

PeopleForBikes

Who Can Apply

PeopleForBikes accepts grant applications from non-profit organizations with a focus on bicycling, active transportation, or community development, from city or county agencies or departments, and from state or federal agencies working locally. PeopleForBikes only funds projects in the United States. Requests must support a specific project or program; they do not grant funds for general operating costs.

What They Fund

PeopleForBikes focuses most grant funds on bicycle infrastructure projects such as:

- Bike paths, lanes, trails, and bridges
- BMX bike parks and pump tracks
- End-of-trip facilities such as bike racks, bike parking, and bike repair stations.

They also fund some advocacy projects, such as:

- Programs that transform city streets, such as Ciclovías or Open Streets Days.
- Campaigns to increase the investment in bicycle infrastructure .

PeopleForBikes will fund engineering and design work, construction costs including materials, labor, and equipment rental, and reasonable volunteer support costs. For advocacy projects, we will fund staffing that is directly related to accomplishing the goals of the initiative.

PeopleForBikes accepts requests for funding of up to \$10,000. They do not require a specific percentage match, but we do look at leverage and funding partnerships very carefully. They will not consider grant requests in which their funding would amount to 50% or more of the project budget.

PeopleForBikes generally holds 1-2 open grant cycles every year. In an effort to green the grants process, they have moved to an online grant application system : <https://peopleforbikes.org/grant-guidelines/>

Highway Safety Improvement Program (HSIP)

The Highway Safety Improvement Program (HSIP) aims to achieve a significant reduction in traffic fatalities and serious accidents through the implementation of infrastructure-related highway safety improvements on all public roads, including non-State-owned roads and roads on tribal land.
