

- Streamline Categories and Questions Combine categories and some questions
 - Combine Planning and Policy Tools
 categories
 - Some questions are redundant
 - Streamlining will make the process easier for the applicants and the judges
 - Propose going from 14 scorable questions to 10



- Adjust weights to 1-5 instead of 1 to 20
 - Some questions should be worth more, but not so much more that a bad project with a good resiliency component could score significantly higher than a good project with a mediocre resiliency component
