FORT BEND COUNTY FY2020 ACTION PLAN

Background:

Fort Bend County Community Development & Welfare Department is requesting a review of the County's FY2020 Proposed Action Plan for the U.S. Department of Housing and Urban Development (HUD). The purpose of Fort Bend County's Annual Action Plan is to identify the objective and outcome for the Fiscal Year 2020 funds for HUD's Community Development Block Grants, HOME funds, and Emergency Services Grants.

Current Situation:

The U.S. Department of Housing and Urban Development (HUD) has allocated \$3,312,369 in Community Development Block Grant (CDBG), \$865,458 in HOME, and \$271,528 in Emergency Solutions Grant (ESG) Program funds to Fort Bend County for FY 2020. These funds cover the period from September 1, 2020 to August 31, 2021.

Fort Bend County is an entitlement community and receives Community Development Block Grants, HOME, and Emergency Services Grants directly from HUD.

CLEAN DIESEL EMISSION REDUCTION

Background:

The United States Environmental Protection Agency is awarding \$44 million in grants to eligible entities as part of the 2020 Diesel Emission Reduction Act - Clean Diesel Funding Assistance Program. This program solicits proposals annually from across the nation to fund projects that achieve significant reductions in diesel emissions. Specifically, this program focuses on distributing funding to areas that have been designated as having poor air quality. The projects with operations in Houston are eligible for funding under this program.

Current Situation:

The Environmental Protection Agency has provided preliminary approval for a competitive federal grant application, submitted by the Coalition for Sustainable Initiatives Inc. This project will operate out of three metropolitan regions, including Houston, within the State of Texas and will work with United Parcel Service to replace 29 short-haul diesel trucks with the same number of equivalent models to be powered by compressed natural gas. It is anticipated that these trucks will carry freight throughout Texas and between the Houston, Dallas, and San Antonio regions. Over the lifetime of the project, it is expected to reduce approximately 101 tons of NOx and over 4 million gallons of diesel fuel. The grant under review includes \$5,290,800 in funding for the Coalition for Sustainable Initiatives' Clean Diesel Grant project. A grant of \$1,636,800 will provided by Environmental Protection Agency, while an estimated \$3,654,000 will be provided by other leveraged funds.

The project is consistent with the goals of the 2020-2021 Unified Planning Work Program for the Houston-Galveston Transportation Management Area, the 2045 Regional Transportation Plan, and is supportive of H-GAC's policies and efforts to improve regional air quality and meet the National Ambient Air Quality Standard for ozone.
