

**6. RECOMMENDATIONS TO FILL VACANCIES ON THE TAC SUBCOMMITTEES**

**Background**

The Transportation Advisory Committee (TAC) has six subcommittees: Transportation Systems Management and Operations, Pedestrian-Bicyclist Subcommittee, Regional Transportation Plan Subcommittee, Regional Transit Coordination Subcommittee, Transportation Air Quality Subcommittee and Transportation Improvement Program Subcommittee.
