10C. LEGISLATIVE UPDATE

Background

Staff has followed state and federal legislation related to transportation and Houston Galveston region. The 87th Texas Legislative session ended May 31, 2021 with the passage of two related bills (subject to approval by Governor Abbott). Federal legislation under consideration includes the American Jobs Plan and the reauthorization of the Fix American Surface Transportation Act (FAST).

Current Situation

The 87th Texas Legislature has focused on issues besides transportation. Fewer bills were filed in this session related to transportation and air quality than in the 86th Legislature. Only nine substantive bills (listed on table on the next page) even made it out of their committee; eight passed one chamber of the legislature. However, only two (highlighted in green on the table) passed both houses and made it as far as the Governor's desk and are still subject to approval.

Senate Bill 1990 sponsored by Senator Miles would allow advanced technology systems and ability of the Gulf Coast Rail District to advance high capacity transit. The bill is signed, would provide opportunity for the expansion or commuter, light rail and bus rapid transit services in Houston with the possibility of coordination to use available right of way of the freight rail district.

House Bill 1698 sponsored by Representative Raney would allow counties with a population exceeding 190,000 but not more than 1,500,000 to increase their registration fee by up to \$10 for transportation purposes. However, the increase would require approval in an electoral referendum. It would impact Fort Bend, Montgomery, Brazoria and Galveston Counties in out region. At the federal level, the American Jobs Plan future is uncertain due to a variety of issues that have been covered in depth in the media. Each political party is far apart in its prioritization and proposed amount of spending on infrastructure spending. There are varied perspectives and disagreements on definition of infrastructure and mechanisms to fund the bill. Senate rules, such as the filibuster and reconciliation, may be critical to its passage or failure. Passage of an infrastructure bill proposed would certainly have an impact on transportation funding and lead to increases in repair and maintenance of roads, bridges, airports and transit assets.

Reconciliation of the FAST Act has overshadowed discussions of the American Jobs Plan. Consideration of possible increases have been discussed by both parties, but its action is likely to be deferred to the American Jobs Plan is resolved.
