1. Call to Order

- Chair Brian Alcott calls the meeting to order at 1:32 PM.
- Quorum achieved.

2. Meeting Minutes

- Stephen Keen went over the July Meeting Minutes Recap.
- No questions or comments over the July Meeting Minutes.
- Brian motioned to accept Meeting Minutes.

3. What we heard: July RTP Subcommittee Meeting

- Stephen went on overview any questions or comments from the July RTP Subcommittee.
 - Are there performance measures related to greenhouse gas emissions? –
 There was a proposal to do so, but USDOT has not adopted a greenhouse gas emission performance measure as of now.
 - Are performance measures an aspect for submitting project to the RTP and TIP? – Yes! The RTP goals have corresponding desired outcomes, which are based on our performance measures.

4. Reliability, Congestion, and Air Quality Performance Measures: Endorsement

- Karen Owen presented the Performance Measures which included:
 - o Reliability
 - Personal & Truck Travel
 - Congestion
 - Peak Hour Excessive Delay
 - Non-Single occupant Vehicles
 - Air Quality
 - Tailpipe emission reductions from Congestion Mitigation Air Quality (CMAQ) projects
- Karen reviewed the 2024 Actual Performance results based off the 2023 traffic conditions as well as the 2026 Target Adjustments.
- Karen had slides and graphs overlooking the Actual Performance results and Target Adjustments for Reliable Person-Miles, Truck Travel Time Index, Peak Hour Delays, Non-Single Occupant Vehicles, and On-Road Moile Source Emission Reductions.
- Karen also provided the meeting an overview of her project schedule, with a deadline of October 1st.
- Peter Eccles asked if there is a standalone performance measure for transit travel time? Karen answered No, as it is a pretty complex measure without the readily available data but it is something they like to look at for the future.

- David Gao asked a question on how the Actual Performance and Target numbers were calculated? – Karen explained the each category of travel is a small percentage of a whole 100% value, so when shown on the graph ranging from 19-26 those are the actual and projected percentages they accounted for within all vehicles.
- Katherine Summerlin asked a question on if the performance measures are standard or federally required metrics? Karen answered USDOT through the FHWA has come up with these measures and it is a very prescriptive calculation for which every MPO tracks and report, while non-attainment regions have even more additional measures to calculate these numbers.
- Brian motioned for endorsement and was moved to approve.

5. Update on RTP Project Development Process

- Application date closed on Wednesday, August 7th
 - o 99 projects submitted
 - o 12 project sponsors
 - o Staff working on timeline
 - o New fiscally constrained RTP project list expected for preview in October
- Next steps and tentative timeline
 - o Internal Evaluations
 - H-GAC will evaluate projects over the next month
 - Fiscal Constraint
 - Expenditures and revenues
 - Illustrative List (if necessary)
 - If expenditures > revenues, an Illustrative List will be developed
 - Project sponsor notification
 - Staff will offer project sponsors the opportunity to meet and discuss project statues (Middle to end of September)
 - o Project list to RTP Subcommittee, TAC, and TPC
 - Preview in October, Action in November
