#### 5A. SUMMARY OF TRANSPORTATION PLANNING ACTIVITIES

#### LONG RANGE PLANNING

## 1. Sub-regional Planning Initiatives (SPI)

- Chambers County Thoroughfare Plan study began July 1, 2023. The study team has updated the Thoroughfare Plan based on comments received January 30, 2024, Steering Committee meeting. The updated draft Thoroughfare Plan will be presented to the Stakeholders on April 18, 2024.
- Washington Avenue Corridor study began October 1, 2023. The study kick-off meeting was held in December. The first Steering Committee meeting was held in April 2024.
- Old 6th Ward/TIRZ 13 Mobility study began November 1, 2023. The study team will be having the first public outreach event on April 20, 2024, at **The Deck at Silver Street Studios** from noon 3pm. The team will be receiving feedback on where the mobility issues are in the study area.
- FM 518 Corridor study began November 1, 2023. The study team held its first public outreach event on April 6, 2024, at the Pearland Spring Fest.
- Pearland Mobility study began November 1, 2023. The study team held its first public outreach event on April 6, 2024, at the Pearland Spring Fest.
- Cemetery Road Corridor Study began March 1, 2024. The first Steering Committee will be May 2024.
- Friendswood's Parkway Corridor study is currently being procured. This project is included in the 2024 Unified Planning Work Program (UPWP) and is scheduled to begin in the Summer of 2024.

### 2. Freight Planning

- The Greater Houston Freight Committee (GHFC) meeting was held on February 28, 2024. The next meeting is scheduled for April 18, 2024.
- The 2023 Regional Goods Movement Plan (RGMP) has ended. The next step is for the plan to be adopted by TPC at the April 26, 2024 meeting. For more information visit: <a href="www.engage.h-gac.com">www.engage.h-gac.com</a>
- The Houston Area Rail Transformation (HART) was presented to TAC and TPC in December of 2022 as a working group formed to coordinate and prioritize regional freight infrastructure to seek grant funding opportunities. The Gulf Coast Rail District (GCRD) formalized the working group as a GCRD committee on January 17, 2023. Two groups have been developed as working groups of HART.
- The Grants Group was developed in June 2023 to assess the readiness of regional partners for upcoming grant submittals and provide letters of support to demonstrate regional support for projects. From July 2023 to December 2023, the priority list representing the regional issues seen at grade crossings was submitted to TxDOT for inclusion into their Phase 2 Rail Study.
- The Unfunded Needs Group was developed in September 2023 to identify unfunded regional needs and align the region for future Rail Relocation Funds. From September 2023 to February 2024, the unfunded needs group began discussing the methodology and criteria needed to begin the assessment.

• The HART working group meets monthly following TPC. H-GAC staff continues to provide meeting support and regional coordination. The next meeting is planned for March 22, 2024.

# 3. Regional Incident Management, Safety, and Operations

- H-GAC staff conducted a Tow and Go Operations meeting with the Harris County Sheriff Office (HCSO), Houston Police Department (HPD), AECOM, TxDOT, and the Towing industry at Houston TranStar.
- H-GAC staff conducted a Traffic Incident Management meeting at Houston TranStar. The meeting had representatives from TxDOT, HCSO, HPD, AECOM, Hazmat, SH288 and the Towing Industry.
- The Tow and Go Public Awareness Campaign is live with educational information streaming on radio, through digital and social media, and billboards across the region.
- H-GAC Staff is working on a Hurricane Preparedness and Awareness Campaign for 2024.
- H-GAC staff attended multiple jurisdiction meetings to confirm there are no changes to the hurricane evacuation routes and zip zones.
- H-GAC staff conducted two meetings with consultant on regional ITS Architecture project. They will present to TSMO Subcommittee in May.
- "Tow and Go" performed 3,011 "No Cost Tows" in March 2024. March's average clearance time was 15 minutes and 44 seconds.

## 4. Environmental Planning

- Staff are updating the land use\landcover base map of the Eco-Logical tool based on recent aerial photography. Further enhancement of the tool will include links to existing environmental assessment and final environmental impact statements for roadway projects within the planning H-GAC region. Staff will coordinate with TxDOT and consultants working on local Planning and Environmental Linkages studies to examine the application of Ecological tools on those studies.
- Staff continue to follow local Environmental Justice news as they relate to the H-GAC Title VI Nondiscrimination Program and will inform the triennial update to the regional Title VI Program Update and report on activities in furtherance of Environmental Justice.

## 5. Resiliency Planning

H-GAC's MPO was one of the 80 recipients that will receive funding from the PROTECT
Discretionary Grant Program. The program awarded \$829.6 million in grant funding to
fund projects to improve the resilience of the surface transportation system.

H-GAC will receive \$1.1 million to develop a Regional Resilience Improvement Plan for the surface transportation system of an eight-county region that experiences repeated extreme weather events, natural disasters, and hazardous flooding conditions. The project will finetune previously developed strategies, identify gaps in planning, create a list of priority improvements that can be implemented in the short- and long term, and include a risk-based assessment of vulnerabilities to roadways, culverts, ditches, medians, and other transportation assets.

- Staff coordinated letters of support for regional partners PROTECT Grant Program applications.
- Staff completed work on the Resilience & Durability Pilot project as part of the FHWA program to
  develop transportation-specific resiliency best practices and strategies. The draft report has been
  finalized and accepted by FHWA. Staff has completed an update of the Foresight Panel on
  Environmental Effects report with outcomes from the Pilot project. For more information visit:

## 6. Regional Transportation Plan (RTP)

- The Regional Transportation Plan (RTP) subcommittee provides guidance and oversees the progress of the RTP. The committee must meet quorum and meetings are held every second Wednesday of the month. The next meeting is May 8, 2024.
- The 2045 RTP Update was approved by TPC in April 2023. The final report and 33 associated appendixes are available online: <a href="https://engage.h-gac.com/2045rtpupdate">https://engage.h-gac.com/2045rtpupdate</a>
- Staff has finalized the RTP Project Development Process online portal and is in the final stages of internal approval.
- The project sponsor workshop for the RTP Project Development Process is coming together and a date will be selected soon. Once selected, staff will notify our local partners of the date, time, and location of the project workshop.
  - The purpose of the project workshop is to: present the RTP Project Development Process, reveal the online portal, and provide presentations on data applications that can be used to submit a successful project application to the RTP.

#### 7. Other Planning Activities

- Staff continued to monitor regional travel impacts of COVID-19. Regional travel volumes were
  monitored through StreetLight data. Transit ridership numbers are now reported quarterly from
  transit agencies in the region. Permanent pedestrian/bicyclist counters provide updates on counts
  along regional pedestrian/bicyclist facilities. Staff have developed an online COVID-19 Regional
  Traffic Impacts App which displays vehicular, active, and transit transportation patterns during the
  Pandemic.
- Work is ongoing towards the update of the Language Access Plan (LAP). The Language Access Plan identifies the language needs in the minority population and specifies policies and strategies the agency will employ to enable individuals who do not speak English proficiently to enjoy meaningful participation in agency programs and activities. Efforts to update the LAP includes a survey to gather information about regional language use and factors that impact the level of public involvement in agency activities. Other related activities include the community roundtables which are aimed at opening a dialogue with advocates, representatives, and members of the different racial and ethnic minority groups and other underserved populations in the greater Houston metropolitan region, to help H-GAC understand how best to engage with these communities and encourage their participation in the civic planning decision-making that affect their lives, health, and environment. Information gathered will assist the update to the Language Access Plan (LAP) and the triennial update to the H-GAC Title VI Plan. The community

- roundtable events will commence in February with meetings with the Korean Community and Chinese Communities. The roundtables will continue through March 2024.
- Staff are beginning the planning process for a February 2024 webinar event commemorating the
  anniversaries of the passage of Title VI of the Civil Rights Act of 1964 and Executive Order
  12898 on Environmental Justice. The webinar is presented under the Title VI and Environmental
  Justice Awareness Initiative with a goal to event will educate staff and stakeholders on vital Title
  VI/Equity issues relevant to MPOs, municipalities, and other recipients of federal financial
  assistance.

#### SHORT RANGE PLANNING

### 1. Project Programming

- Staff coordinated the amendments to the 2023-2026 TIP document. Staff coordinated with TxDOT and local governments on the proposed amendments to the 2045 Regional Transportation Plan.
- Staff met with local sponsors as part of the quarterly TIP monitoring efforts.
- Staff worked on the development of project selection criteria for the next Call for Projects and coordinated with various subcommittees.
- Staff completed the project selection process for the Carryover Balance projects. These are projects that can be ready for implementation within the next 2 years. The effort included the selection of over \$335 M in surface transportation projects identified for project development activities and construction. Over the spring, staff will work to program these projects into the Statewide Transportation Improvement Program.
- Staff completed and the TPC approved projects for the Regional Goods Movement investment criteria. Over \$150M in regional projects that encourage the safe and efficient movement of goods in the region. These projects will be submitted into the Statewide Transportation Improvement Program in the Spring of 2024.

### 2. Pedestrian and Bicyclist Planning

- Staff are continuing to work with the Data Analytics department to update the Regional Bike Network Map. Larger communities that have submitted their data are now live on the Regional Bike Network map. Staff have started the process of updating the Sidewalk data layer.
- The consultant selection process for the Connecting Buffalo Bayou East Design Concept study continues with execution of consultant contract and ILA by April 2024.
- The scope of work was refined for the Memorial Drive study as it enters the procurement process for consultant selection.
- Staff refined the scope of work for the City of Friendswood Master Trails plan as it enters the procurement process for consultant selection.
- The Bay Area Ped Bike study is ongoing. Consultants, staff and volunteers conducted walk/bike in March at key locations throughout the study area. A project task force meeting is planned for April 25. Development of recommendations is ongoing.

- Staff attended various meetings such as the City of Houston Bicycle Advisory Committees, Texas Pedestrian Coalition, Houston Safety Task Force, etc.
- Staff worked with Procurement to publish a request for proposal for counter installation work, which closed on January 11<sup>th</sup>. Staff confirmed that mobile counter activities are also eligible for inclusion in the contract. Staff are working to confirm if the budget for this expanded contract may necessitate board of directors approval.

## 3. Transit Planning

- The Regional Transit Coordination Subcommittee held its regular quarterly meeting on Thursday, April 11, 2024.
- US 90A Corridor Transit Study began in March, with a project kick-off meeting held on March 12, 2024. Project management and data collection activities are currently underway.
- Funding for the RFP for the Dayton Transit Study and negotiations for a finalized contract are underway with the selected consultants.
- The Pearland Transit Study Alternatives Analysis draft was completed, and preparation of the Draft Final Report is underway. We are extending our review of alternatives to examine additional options for delivering transit service based on feedback from the City of Pearland.
- Community Public Meetings on the study were held on March 19 and 21. It was followed up by the gathering of additional comments through the website. regarding the potential alternatives by Pearland residents.
- A presentation on the status of the Pearland Transit Study was provided to the RCTS in April and will be prepared for TAC and TPC in May.
- The Board of Directors approved two years of funding for Microtransit pilot service in the City of Sugar Land. Preparation of the interlocal contract has begun. Service is expected to begin midyear.
- CMAQ Commuter pilot service provided by Fort Bend Transit began on March 4 with initial ridership numbers exceeding expectations. Monthly commuter ridership exceeded 3,300 in March 2024.
- Staff are working with METRO and regional transit partners to continue implementation of the Regional Transit Connectivity Project. Harris County Transit and Fort Bend Transit have gone live with Mobile Ticketing under the new partnership project. H-GAC and METRO are currently working to integrate all partners into the Regional Data Management System.
- The Regional Transit Coordination Subcommittee approved a new methodology for the Regionally Coordinated Transportation Plan's Transit Need Index in January 2024. Staff are working with the region's transit agencies to gather necessary data to implement this methodology.
- Data collection for Transit Asset Management performance measures is complete. Staff have
  contacted all agencies & have updated plans from all agencies. Staff began presenting the results
  to internal subcommittees in February. Staff presented to TAC & TPC for information in March.
  Staff will present to TAC for recommendation of FY 2026 targets & to TPC for approval of these
  targets in April.

#### TRANSPORTATION PUBLIC OUTREACH

- A Provider Summit for providers of Paratransit and Non-Emergency Medical Transportation services will be held on June 25, 2024, at H-GAC offices, from 11 AM to 2 PM. The event will include small group discussions, a networking hour, and a panel discussion. A host committee has been formed and met, and development of activities and marketing materials is underway.

### COMMUTE SOLUTIONS

- Commute Solutions continues to work with the H-GAC Data & Analytics Research team and the Air Quality teams in planning efforts for Ozone Action Month.
- Commute Solutions completed the draft RFP for Emergency Ride Home.
- Staff attended the Riverstone community Bunny Hop and Brunch event where we educated residents on alternative commuting options such as the new Fort Bend Transit route to Downtown.
- Commute Solutions and Houston ConnectSmart continued planning efforts with Rice University to launch the campus carpool program. The campus will undergo a soft launch and pilot beginning in April with plans to fully launch next fall.
- Commute Solutions and the TDM team will be hosting the quarterly Regional TDM Workgroup
  meeting this month. The workgroup is a collective of the region's transit partners where agencies
  provide updates of upcoming programs and initiatives and discuss goals and collaborative
  opportunities.
- Commute Solutions continued planning efforts for a campaign and related toolkit to assist
  employers with launching the ConnectSmart app. The campaign should launch during Earth
  Month (April). The team will also participate in worksite and community events to provide
  educational materials that show the relationship between commuting and environmental
  sustainability.
- AECOM, the contractor executing the evaluation and recommendations for Commute Solutions, continued with the project plan by submitting the initial draft of the recommendations for the program.

#### CLEAN VEHICLES PROGRAMS PLANNING ACTIVITIES

- Staff continue to work on a project to reassess the availability of Buy America compliant vehicles suitable for inclusion as part of the Clean Vehicles Program. Staff are continuing to work to reach out to manufacturers of vehicles and related charging equipment to discuss Buy America requirements and the availability of compliant equipment. Staff are also working with in-house council to understand available options and to review recent revisions to federal Buy America rules and understand how agency programs can best comply. This work is ongoing.
- Staff worked with grant recipients who have recently received vehicle deliveries to support ongoing
  grant activities, undertake the vehicle acceptance and invoice process, and processing invoice
  materials.
- Staff continued to monitor post-delivery projects that have not yet met the contractually required emission reductions based upon subrecipient performance. This monitoring effort ensures that grant recipients' usage of vehicles remains within grant requirements and that vehicle use and mileage commitments are met. Historically, this monitoring effort has occurred through a mix of subrecipient self-reporting and automated GPS monitoring.
- Staff continued to process contract closeouts for projects meeting minimum contracted
  requirements for all project vehicles and is working to complete this closeout process when
  possible. In the last month, staff processed and released seven vehicle replacement contracts as
  well as one vehicle title for project partners that had successfully completed their grant and/or
  loan requirements.

#### GENERAL AIR QUALITY PLANNING ACTIVITIES

- H-GAC continues to administer \$1 million in planning funds through the EPA Climate Pollution Reduction Grant (CPRG). Staff have completed the contract signature process on all project partner agreements. The final Priority Climate Action Plan was submitted to EPA on March 1. With that process completed, the team pivoted towards developing materials to be completed in a regional implementation grant application. This application was submitted to EPA on April 1 and included five regional project partners and 13 projects derived from a call for projects process that was undertaken as part of the Priority Climate Action Plan. Activities included in this proposal totaled \$162 million.
- H-GAC continued to work on regional efforts to support the Department of Energy sponsored Houston-Galveston Clean Cities Coalition. Under this program, staff worked with regional fleets to foster economic, environmental, and energy security by working to advance affordable, domestic transportation fuels, energy efficient mobility systems, and other fuel-saving technologies and practices.
- Staff continues to administer two separate Environmental Protection Agency-funded Diesel
  Emissions Reduction Act (DERA) grants from the 2018 and 2019 Calls for Projects to deploy allelectric yard tractors at local freight warehouses. Staff have been working with IKEA to replace two
  existing diesel yard tractors at their Baytown facility with all-electric models.

#### TRAVEL DEMAND MODELING & FORECASTING

- Staff continues to provide travel demand and forecasting modeling technical support to the Regional Transportation Plan (RTP), Transportation Improvement Programs (TIP), and other traffic and travel related data developments within the H-GAC MPO region that supports sub-regional and corridor studies for both TxDOT and other H-GAC member agencies projects such as: the Regional PEL study Scenario D for the Beltway 8/I 10E DCs updates, the Washington Ave ADTs and Design Parameters study, BCTRA-SH 288 toll study, Cemetery Road Corridor Study, Chambers County Thoroughfare Plan Project, Fort Bend Transit Ridership (Ozone Action Data), US 90A Transit Corridor Study, Chambers County ADTs and Traffic Factor for Hatcherville Rd, Belton Lane, the use of various data and analysis to support the Transportation Department in the Performance Measure (PM3) analysis, provide support in updating the table for means of transportation to work for Houston and Conroe, and the Woodland's UZA using ACS 2021 AND 2022 5-year average, assist in generating Park Management Plan (for North Houston PKWY), and provides support to the City of Houston for the Houston's community-wide GHG emissions inventory for transportation emissions and VMT activity for the Houston jurisdiction.
- Staff continues with the on-going review, update and processing of the H-GAC traffic count and recount from various traffic data collection within the H-GAC region, VisionEval new scenario development and Update of the VisionEval model with updated software, and continue with the review and QA/QC of the traffic Analysis Zones (TAZ), and document to support new growths in certain H-GAC MPO areas.
- Staff continues to meet and seek professional advice from the TTI to come up with recommendation of methodology, goals and objectives to TxDOT TP&P for the Commercial Vehicle survey H-GAC would like to conduct. Staff continues to coordinate with the TxDOT TP&P for the Household Survey expansion within H-GAC Metropolitan Planning Organization (MPO) region, and continues to coordinate with the TxDOT TP&P on conducting University and Community Colleges Surveys of University of Texas Medical Branch (UTMB), Texas A&M University at Galveston (TAMUG), and the Galveston College two campuses in Galveston county, continues to review both the executive summary and general reports of the Airport Survey, and continues with the amendment of the ETC Airport Survey contract to allow for the development of the optional task #6 (airport sub-model development) of the original scope of work, working with the Procurement team for the Active Transportation Survey for the Bike & Pedestrians data collection within the H-GAC MPO region.
- Staff continues with the Activity-Based-Model (ABM) model troubleshooting and sensitive testing.
- Staff continues to develop Travel Demand Model QA/QC process, supplied 13-county VMT data for the CPRG from TTI, continues to support Transportation's CPRG project, and continues working on new template for conformity process
