10. CALL FOR PROJECTS (ACTION ITEM)

Background

At the March 2020 Transportation Policy Council (TPC) meeting the Council approved goals, priorities, and policies for the next Call for Projects. These goals, priorities and policies guide the H-GAC staff, Transportation Advisory Committee (TAC) and the Transportation Improvement Program (TIP) Subcommittee in development of project selection criteria and evaluation methodologies for the next Call for Projects.

Current Situation

On February 11th, the Transportation Improvement Program (TIP) Subcommittee met to continue discussions on the next call for projects. The objectives for this meeting were to understand key elements of the process including sponsor and project eligibility. Additionally, four key core issues were brought to the Subcommittee with the goal of reaching consensus before bringing the issues to the Transportation Advisory Committee (TAC). The core issues discussed include:

- 1. Investment Categories
- 2. Split of scoring between Benefit/Cost analysis and Planning Factors
- 3. Rural funding allocation and ranking process

After an extensive discussion a consensus was reached on the following items.

1. Investment Categories:

Potential eligible sponsors can submit projects in one of the five investment categories listed below:

- a. Major Investments: All roadway, freight or transit projects that have a total project cost of \$100M or more. Total project cost (federal + match) will include all phases (including Engineering, Environmental, ROW, Utility and Construction).
- b. Expand: All roadway, freight or transit projects that expand the network capacities.
- c. Manage: All roadway, freight or transit projects that improve operations of existing networks.
- d. Maintain: All roadway, freight or transit projects that extend the useful life of the existing networks or improve the resiliency of the existing networks.
- e. Active Transportation: All projects that expand, manage or maintain bicycle and pedestrian infrastructure and provide alternative choices to essential trip making.

2. Split scoring between Benefit/Cost analysis and Planning Factors:

Roadway, freight, and transit projects will be scored on a 200-point scale with 50% (100 points) weight given to Benefits/Cost analysis and 50% weight given to the Planning Factor responses.

Active transportation projects will be scored on a 200-point scale with 20% (40 points) weight given to Benefits/Cost analysis and 80% (160 points) weight given to the Planning Factor responses.

3. Rural funding allocation and ranking process:

Staff presented two options for consideration on the ranking and allocating 9% of the total available funding to rural projects. After extensive discussion the Subcommittee reached consensus on the following scenario:

Combined rural and urban ranking process: 9 percent of funds will be allocated to projects in the rural portion of the adjusted urbanized area for the region using the following process:

- 1. Planning factors criteria scores for rural and urban projects will be the same;
- 2. Total scores (planning factors score + B/C ratio score) of rural and urban projects submitted in an investment category will be ranked in descending order;
 - a. Projects submitted in the Major Investment funding category but in the rural portion of the region will not be considered as rural;
- 3. Projects (rural and urban) will be selected in descending order for each investment category until programmable funds have been expended;
- 4. If the 9 percent rural allocation floor of funds in a category is not met, then additional rural projects will be selected to satisfy the floor;
 - a. Moving rural projects above the funding level may shift urban projects below the funding cut-off; they will not be funded;
 - b. Rural projects must meet a minimum score threshold to be eligible for selection. The threshold will be determined after the full scoring process is completed; the threshold will be reviewed and approved by the TPC before it is implemented;
- 5. If the 9 percent floor within any investment category cannot be satisfied with eligible rural projects (e.g., those scoring higher than the minimum threshold), then the programmable balance from that category will be reduced by the difference and funds will be assigned to additional rural projects in other investment categories;
 - a. Rural projects with the highest benefit-cost analysis scores will be selected in their investment category until the overall 9 percent floor has been met.
 - b. Ties in scores between rural projects will be resolved by using the benefit-cost analysis score for the project.

Action Requested

TAC Recommendation for TPC approval of:

- Five Investment Categories
 - o Major Investments, Expand, Manage, Maintain, Active Transportation

- Split scoring with Benefit-cast Analysis and Planning Factors
 - O Major Investments, Expand, Manage, Maintain (50% BCA/50% PF)
 - o Active Transportation (20% BCA, 80% PF)
- 9% rural funding allocation with combined ranking process
 - O All projects urban or rural use same planning criteria
 - o All projects will be listed in descending order by investment category
 - o Projects selected in descending order until the budget is used
 - o Check on the 9% budget for rural projects
 - If it is not met the rural project below the funding line will be selected until
 9% rural allocation is met
