4. Discussion was held on ITS Regional Architecture around the region. It was suggested that regional government agency give presentations on their ITS architecture accomplishments and experiences in implantation. Also, discussion was held on updating the ITS Architecture
5. Preliminary discussions were had on the Planning and Environmental Linkage (PEL) Studies that are being done in the TxDOT Houston District. The studies discussed are:
 - Gulf Freeway (I-45 South) PEL: From US 59 / I-69 to Beltway 8 South in Harris County
 - I-10 East PEL: From I-69/US 59 to SH 99 (Grand Parkway) in Harris and Chambers Counties
 - I-45 PEL: From Beltway (BW) 8 to Loop 336 South in Harris and Montgomery Counties
 - I-69 PEL: From Spur 527 to BW 8 in Harris County
 - SH 225 and I-610 East PEL: SH 225 from I-610 to SH 146 and I-610 East from Broadway Street to Clinton Drive in Harris County
6. Steve Chiu with TxDOT gave a presentation Roadway to Vehicle Communications that TxDOT is placing on some of roadways around the Houston District. I
